With due respect I Anil Kama Jang (male/46 yrs)  
s/o Yang Dassee Jang  
residents of Vashu Residency, Vanchijoto, New Chantā, Po-New Chantā  
Ps-Matigara, Dist-Darjeeling would like to inform you that I have a  
office in city centre Block 5th floor Room No. 507 by the name of  
"Axen opportunities"

Today i.e. 5/2/26 at around 14:50 hrs, Abinash Cheltri (resident  
of Sonada) Ritika Rai w/o Firoz Rai (resident of Rajbari) Guman Sarkar  
(resident of Goshpukur) along with ten to fifteen people forcefully  
entered my office and assaulted me physically which left me unconscious  
when i gained partial consciousness they were dragging me out of my  
office still assaulting me, after that they forcefully took me with  
them outside and later in an Auto to Raju Nagar area.

After they took me there i was held hostage in the  
house of the relative of Abinash Cheltri. There i was surrounded by  
10 to 15 men who threatened me with my life and without my knowledge  
they made me sign an agreement, the contents of which not known to  
me. They also forcefully took my fourwheeler bearing Registration No.  
WB 74 ALO 770 (Ford EcoSport) white in colour, along with documents.

After having done all the above acts one person among  
them dropped me in Darjeeling more at around 9:50 pm.

I would also like to mention the agreement along with  
the promissory note was made to sign by me in the presence of an  
advocate named Rupesh Cheltri from their side.

I request you to kindly take strict action and necessary  
legal steps as early as possible because my safety is at risk.
