In producing herewith one arrested accused person namely Ramesh Mandal (36yrs approx) S/O- Chalittar Mandal, Of Kailughat, PO- New Chumta, PS-Matigara, Dist- Darjeeling along with seized vehicle displaying Reg. No. WB 53 B 3737 loaded with riverbed materials (Stone), I ASI Bikash Roy of Matigara P.S, SPC do hereby lodge a written Complaint against the above noted accused person to the effect that on 06.02.2026 at 19:05 hrs received an information from reliable source that one TATA Dumper vehicle loaded with illegally mining riverbed materials is coming from Kailughat towards Maqbul Busty. On receiving the information informed to I/C PS and as per his kind direction myself along with forces rushed to the spot to work out the information. At around 19:35 hrs on arrival at Maqbul Busty More, Panchkolguri under Matigara P.S area I found one TATA Dumper vehicle displaying Reg. No. WB 53 B 3737 loaded with riverbed materials is coming towards Maqbul Busty. Subsequently, I managed to stop the vehicle. The driver introduced his name and address as noted above. I asked the driver to produce valid documents / papers of the said riverbed materials but he failed to produce any valid documents or papers in respect of the said riverbed materials but on being asked he admitted that he loaded the riverbed materials from the Kailughat. There was a sufficient reason to believe that the above noted accused driver of above noted vehicle has procured the river bed materials illegally without any proper royalty/ papers as per rule, for selling clandestinely for their wrongful gain. Accordingly, I seized the above noted loaded TATA Dumper vehicle displaying Reg. No. WB 53 B 3737 along with river bed materials under proper seizure list and arrested the driver namely Ramesh Mandal (36yrs approx) S/O- Chalittar Mandal, Of Kailughat, PO- New Chumta, PS-Matigara, Dist- Darjeeling. The whole process of search & seizure and arrest was made in between on 06.02.2026 at 20:00 hrs to 20:10 hrs. The whole process of seizure was made under videography through WB-E- Sakshya Application.

Therefore I pray before you a specific case may kindly be started against the driver/ owner of the vehicle namely Ramesh Mandal (36yrs approx) S/O- Chalittar Mandal, of Kailughat, PO- New Chumta, PS-Matigara, Dist- Darjeeling and the seized vehicle bearing Reg. No. WB 53 B 3737 under proper section of law and arrange for its investigation.
