Sir,
 I, Bijay Lakra, SE (S&LP), Darjeeling Regional Office, WBSEDCL do hereby lodge this complaint to the effect that today (06.02.2026 at 14:44 hours regarding theft of electric energy found during routine inspection with Mr. Samin Mondal, JE(E) Gr-II, Sri Balai Biswas, Gr I TSH Milanpally CCC and other technical personnel had been to the spot at Maharaj Colony, Siliguri.

On physical inspection, it has been detected that said Smt. Mina Devi Prasad (Consumer ID: 400524592 and Meter No.: L1951146) has illegally extended the electricity connection to temporary disconnected of her another premises having Consumer ID: 402065165 and OSD Amount Rs. 33090.63 including LPSC as on 06.02.2026.

She did this intentionally with wrong intention for her wrongful gain.

As Smt. Mina Devi Prasad has committed an offence, punishable under section 135(1) (e) of Electricity Act, 2003. So, inspection memo and seizure list is prepared by seizing the Single core 4sqmm PVC cable (approx length 12m) in presence of witnesses and supplied copies of it to the representative of the accused. The said line has been disconnected. The connected load is found to be 3.26 kVA.

So, it is requested to start a case u/s 135(1)(e) of Electricity Act 2003 (Amendment Act 2007) against Smt. Mina Devi Prasad and arrange for its investigation.
