Sir,

I, Smt. Kajal Sahani, Wife of Sri Kundan Sahani, Daughter of Sri Arabinda Sahani @ Arovind Sahani, resident of Samar Nagar Colony (Middle), Champasari, P.O. & P.S. - Pradhan Nagar, District - Darjeeling, PIN - 734003, would like to bring to your notice the continuous, grave, and heinous acts of cruelty, physical and mental torture, sexual violence, dowry harassment, wrongful confinement and criminal intimidation committed upon me by my husband and his family members since the very inception of my marriage.

I was lawfully married to one Sri Kundan Sahani, Son of Sri Indra Kant Sahani, resident of Ward No. 1, Loutore, Babupara, VTC Sainthia, P.O. - Sainthia, P.S. - Sainthia, District - Birbhum, on 24.02.2025 at Maa Mansa Bhavan, Ward No. 3, Gurung Basti, Pradhan Nagar, according to Hindu rites and customs. After solemnization of the marriage, on 25.02.2025, I accompanied my husband to his parental house at Sainthia, Birbhum, and started residing there with him as husband and wife.

That within merely three to four days of marriage, I discovered that my husband is a habitual drunkard. Under the influence of alcohol, he started physically assaulting me, abusing me in filthy language, and subjecting me to severe mental cruelty. Soon thereafter, my parents-in-law and sister-in-

law also joined hands with my husband and started humiliating and abusing me, repeatedly alleging that I had not brought sufficient dowry, articles, and money from my parental home. I was continuously harassed, insulted, and mentally tortured on this false pretext.

That around 10.03.2025, my husband shifted me to a rented accommodation situated at Dabgram, opposite Women's College, Siliguri. However, even at the said rented premises, the cruelty did not stop. My husband regularly assaulted me with fists and blows. Whenever I protested against such violence or questioned his conduct, he would brutally beat me. On numerous occasions, he forcefully had sexual intercourse with me against my will, even when I was physically unwell or expressly unwilling, thereby subjecting me to extreme physical and emotional trauma.

That whenever I tried to inform my parents-in-law about the torture inflicted upon me, instead of restraining their son, they openly supported him and blamed me. My husband frequently snatched my mobile phone without any reason and kept it with himself for days together so as to prevent me from contacting my family members or seeking help from anyone. After some time, we again shifted back to his parental house at Sainthia, but the physical and mental torture continued unabated. My husband would frequently quarrel with me over trivial issues, behave in an extremely rude and aggressive manner, and also insult and abuse my parental family.

That in or around mid-April 2025, my husband suddenly abandoned me at Sainthia and left for Siliguri without any information or arrangement. During that period, my in-laws again subjected me to verbal abuse and humiliation. Left with no option, I informed my brother and my maternal aunt (masi) about my helpless condition. They came to Sainthia and rescued me by bringing me back to my brother's residence.

That due to the continuous physical assaults and cruelty, my health deteriorated severely. Upon medical examination, the doctor detected a cyst and blood clotting near my stomach region, which was opined to have been caused by the repeated physical beatings and the medicines/pills which my husband had forcefully administered to me without any medical advice. During May 2025, I stayed at my parental home for treatment and recovery. Even during this period, my husband occasionally visited and whenever he got an opportunity, he assaulted and abused me and kept pressurizing me to return to his parental house. I tolerated all such acts silently only to protect the honour and reputation of my family and with a hope that my husband's behaviour might improve.

That it is also extremely painful to state that during my stay at the matrimonial home, my father-in-law created an extremely unsafe and uncomfortable environment for me. He used to touch me inappropriately, stare at me with ill intent, and frequently enter my room without knocking, thereby outraging my modesty and causing me immense fear and mental trauma.

That around June 2025, after consuming excessive alcohol and smoking weed, my husband again became violent and abused me in filthy and obscene language. He repeatedly humiliated and tortured me both physically and mentally. On 18.06.2025, while in a state of intoxication, my husband brutally assaulted me with fists and blows and openly stated that he had no other way to vent his frustration for not receiving sufficient dowry from my parental home.

That in or around mid-August 2025, my husband shifted me once again to another rented flat situated at Electric Office, Dabgram, 2nd Floor, Siliguri. At the said premises, I was not provided proper food, and my husband

would frequently lock the flat from outside while going to office, thereby wrongfully confining me inside the house and preventing me from stepping out or seeking help.

That during late September 2025, at the time of Durga Puja, we visited his parental house again, where I was once more physically assaulted. My husband forcefully packed my belongings and attempted to throw me out of the house. When I resisted, he forcefully made me consume around five to six sleeping pills, as a result of which my condition became critical and I had to be admitted to a hospital on 03.10.2025. After recovering from the said incident, I returned to my parental home. Even thereafter, my husband and in-laws continued to abuse me over phone and through other means and persisted in their unlawful demands for dowry.

That on 16.11.2025, my husband publicly assaulted me by slapping and beating me outside Cosmos Mall, Siliguri, and also verbally abused me in public, thereby causing me immense humiliation. Again, on 30.01.2026, while I was returning from work near Kanchangungha Stadium, Siliguri, my husband suddenly appeared, slapped me, and fled from the spot. When I confronted him thereafter, he threatened to kill me if I dared to take any legal action against him. My family members also attempted to communicate with him to resolve the matter, but he outrightly refused to cooperate and continued to threaten me with dire consequences.

That after enduring prolonged physical violence, sexual abuse, mental torture, humiliation, and threats to my life, and after overcoming immense trauma and fear, I have finally gathered the courage to approach the police authorities and lodge this complaint seeking protection and justice.

That at this juncture, I state that I am continuously being physically assaulted, mentally tortured, sexually abused, wrongfully confined, threatened, humiliated, and harassed for dowry by my husband Sri Kundan

Sahani, and abetted by my father-in-law, mother-in-law, and sister-in-law, whose acts are grave, cognizable, and punishable under law.

I therefore humbly request you to kindly register an FIR, conduct a thorough investigation into the matter, and take strict legal action against the culprits being husband, my father-in-law, my mother-in-law, and my sister-in-law in accordance with law, so as to protect my life, dignity, and legal rights.

I shall remain ever grateful for your kind intervention.
