The Electricity Act' 2003 amended in 2007.**

Sir,

I, Sri Manik Das, (45), Assistant Engineer (Electrical) & Station Manager, NJP Gate Bazar C.C.C, WBSEDCL, (S/O: Sri Akshay Das), do hereby lodge complaint against aforesaid Purnima Das Gupta to the effect that, on 03.02.2026 in course of inspection, myself along with (1) Shri Bijay Lakra, S/O: Bernard Lakra, Superintending Engineer & (2) Shri Bhaben Roy, S/O: Late N.C Roy, SO, both are from Darjeeling Regional office (S & LP wing), WBSEDCL, (3) Shri Sukanta Talukder, Sr. Office Executive, S/O- Late Santosh Talukder, (4) Shri Subhankar Neogi, Linesman, S/O: Late Swapan Kumar Neogi of NJP Gate Bazar CCC & other technical staff of NJP Gate Bazar CCC had been to the premises of Purnima Das Gupta, W/O: Shri Pradip Das Gupta of Shantipara, PO: Bhaktinagar, P.S. NJP, Dist: Jalpaiguri at 12.45 Hrs. Prior entry to the premises, a notice was issued in the name of Purnima Das Gupta for inspection of the said premises which was received by Bani Chakraborty, daughter-in-law of the consumer. I arrange to call witnesses from the vicinity but none turned up. However, in presence of the consumer's representative we conducted inspection.

During inspection it was found that, there has one Domestic connection vide consumer id: 412104649 in the name of Purnima Das Gupta in the premises from which he has made unauthorized extension of line to other premises, where there has a disconnected service line vide consumer number 412111537 in the name of Biru Sarkar, having outstanding due amount Rs. 2234.00. Due to this unauthorized use of electricity WBSEDCL has occur a loss of revenue. On detection of such illegal use of electricity service line i.r.o consumer id: 412104649 was disconnected & the line by which unauthorized extension was made has been dismantled. During inspection load of electricity consumption as observed in the same premises was 1.180 KW. On being asked, Purnima Das Gupta admitted her guilt for committing aforesaid offence. Thus it has well been established that, aforesaid Purnima Das Gupta, W/O: Shri Pradip Das Gupta of Shantipara, PO: Bhaktinagar, P.S. NJP, Dist: Jalpaiguri has committed offence for which he is liable for prosecution U/S 135(1) (e) of The Electricity Act' 2003 amended in 2007.

Inspection report was prepared. I seized the following article under proper seizure list on 03.02.2026 from 12.50 hrs. to 13.07 hrs at the same premises in presence of the consumer's representative.

Seizure: -

1. Single core, 2.5 Sq mm copper wire, Approx. length: 50 Feet.

Copies of seizure list and inspection report were delivered to Bani Chakraborty.

Therefore, I request you to kindly treat this complaint as F.I.R. against aforesaid Purnima Das Gupta and arrange for it's investigation.

Original inspection report, seizure list, notice, one sealed packet containing seized article affixed with original label and another seal packed C.D containing video recording are being handed over to you for necessary action.
