Sir,

With benign submission I, PSI. Sahanur Rahaman presently posted at this PS under your kind disposal producing herewith two arrested accused person namely 1) Tapan Roy (M/24yrs) S/O. Ajoy Roy 2) Amit Roy (M/26) S/O. Dalim Roy both of Bikash Nagar Salugara PS. Bhaktinagar Dist. Jalpaiguri before you and filing this written complainant to the effect that today Dtd. 06.02.2026 I along with C/1427 Swapan Roy & C/1434 Anant Ram Bara was detailed to perform K37 evening patrolling van duty in and around Bhaktinagar PS area vide Bhaktinagar PS ECC No. 450/2026 Date: 06.02.2026 and GDE No. 303 Date: 06.02.2026. During duty at around 20.30 hrs I received information that two persons creating nuisance at Salugara in front of Honda Car Showroom under Bhaktinagar PS. Accordingly I along with force proceed toward the spot.

At around 20.45 hrs I reached at the spot and found two youths creating halla and threatening the guard of a nearby garage named and styled as Swastik Bridge & Road Contract LLP, Siliguri just opposite side of the Honda Showroom. Accordingly I intervene and tried to took control over the situation and I came to learnt that the two youths parked bike in front of the entrance of the garage and when the guard of the garage asked them, not park the bike there then the two youths tried to assault the gateman of the garage and took attempt to run over the gateman by the bike named Randhir Kumar Singh. On hearing the allegations I asked the two youths about their identity and they stated their names as noted above. Thereafter I introduced ourselves as on duty Police personnel & I asked them about the incident but they pay no heed to my wards and uses slangs towards us and going to assault the gateman of the garage in front of Police. Seeing this I along with my force tried to stop them immediately after then they became more aggravated and attacked us and they knowingly obstructing us in discharge of our public duty and also hit one constable of my team named C/1427. Swapan Roy to deter him from his Public duty as a result the named C/1427. Swapan Roy sustained injury and both the accused persons torn off the Police uniform of the constable. Seeing the situation going out of control and finding no other option I arrested both the accused persons using minimum force from the spot maintaining all formalities.

Over this facts and circumstances I therefore pray before you that kindly took charge of the arrested accused persons and a specific case may kindly be started against the accused persons for obstructing public on duty servant, voluntary causing hurt to deter public servant from his duty and use criminal force to deter public servant from his duty against the arrested accused persons namely 1) Tapan Roy (M/24yrs) S/O. Ajoy Roy 2) Amit Roy (M/26) S/O. Dalim Roy both of Bikash Nagar Salugara PS. Bhakjtinagar Dist. Jalpaiguri and arrange for it's investigation.
