Sir,

With due respect, I, Randhir Kumar Singh, S/o Subash Singh, resident of Pindraji, P.S. Phulpur, District Varanasi, Uttar Pradesh, presently working at Swastik Bridge & Road Contract LLP, Siliguri, beg to submit the following for your kind consideration that our construction work is presently going on at NH-10. On 06.02.2026 at about 20.15 hours, while I was on duty, two unknown individuals came on a motorcycle at high speed and fell on the road. Thereafter, both of them approached us and started using filthy and abusive language, physically assaulted me and my staff, and threatened us with dire consequences.

I immediately informed the police. Upon arrival of the police party, the said two individuals misbehaved with the police personnel and physically assaulted the police team. They were found to be under the influence of alcohol. Subsequently, both persons were taken to the police station by the police.

I therefore request you to kindly take necessary legal action against the said individuals as per law.
