Sir,

In producing herewith three (03) arrested accused persons, namely (i) Samrat Das @ Satto (31 yrs) s/o- Lt. Gopal Das of near Jagatbandhu Ashram Road, Netaji Colony, ward no-37, PO- Goghomali, PS- Bhaktinagar, dist- Jalpaiguri (ii) Palash Mandal (32 yrs) s/o Lt. Pujan Mandal of Shantinagar Sporting Club Road, ward no-36, PS- Bhaktinagar, dist- Jalpaiguri and (iii) Subhakar Paul @ Bhula (25 yrs) s/o Sambhu Paul of Amtala near Uttar Bangha Sambad, PO- Goghomali, PS- Bhaktinagar, dist- Jalpaiguri arrested u/s- 35 BNSS along with following seized articles viz:

- (1) One iron-made rod measuring 2 feet inches (approx.) was found from the exclusive possession of Samrat Das @ Satto, which was kept in back.
- (2) One iron-made rod measuring 2 feet inches (approx.) was found from the exclusive possession of Palash Mandal, which was kept in his right hand.
- (3) One charger light red and black in colour was found from the possession of Subhakar Paul @ Bhula which was kept in his left hand.

I, SI Ajen Lepcha, S/O- Lt. Dup Tshering Lepcha of Ashighar OP under Bhaktinagar Police Station, Siliguri Police Commissionerate, do hereby lodge this complaint against the above-noted accused persons, namely (i) Samrat Das @ Satto, (ii) Palash Mandal and (iii) Subhakar Paul @ Bhula and others to the effect that today on 07/11/2025 at 00:05 hrs while performing night patrolling duty received a source information that 12/14 youths have assembled near Tharughati forest office under Bhaktinagar PS with a view to commit dacoity in a house at Bholanathpara area under Bhaktinagar Police Station. Accordingly, the fact was diarised in GD vide Ashighar OP GDE No- 191 dated 07/02/2026. Subsequently, after sharing the information with my superior and as per his direction, I, along with ASI, Tapan Roy, ASI, Dinesh Chandra Roy, C/970 Bikash Roy, C/1547 Prabir Das, C/376 Shyamol Chowdhury and CV/1034 Manojit Barman, all of Ashighar Out Post, left for Tharughati forest to verify the veracity of the source information. At about 00:35 hrs after reaching near Tharughati forest, I met my source and, being pointed by the source, we started walking towards Tharughati forest. At around 00:50 hours, we reached at Tharughati forest and began to cordon off the suspected individuals being identified by my source. We had a strong reason to believe that they were preparing to commit a cognizable offence and were about to leave the area. However, upon noticing the police approaching, they attempted to flee. After a hot chase, we successfully apprehended three accused individuals along with the seized articles mentioned above. Unfortunately, a number of others managed to escape from the spot, taking advantage of the darkness.

During the interrogation, the apprehended individuals admitted that they had gathered there with other associates with a view to commit dacoity at a house in Bholanathpara area under the Bhaktinagar police station.

Following that I, seized the above-noted weapons from their possession under the proper seizure list and videography, duly signed by the witnesses and acknowledged by the accused persons. The whole seizure was made between 01:10 hrs to 01:17 hrs. Thereafter, I arrested the above-noted accused persons u/s 35 BNSS under a proper memo of arrests duly signed by the accused persons and also supplied a copy of the memo of arrest to them.

Subsequently, I brought the arrested accused persons along with the seized articles to Bhaktinagar Police Station for further investigation. During the course of interrogation, it could be revealed from the arrested accused persons that they had gathered there to commit dacoity in a house in Bholanathpara area under Bhaktinagar PS.

Hence, under the above noted facts and circumstances a specific case may kindly be started under proper section of law against the above noted arrested accused persons namely (i) Samrat Das @ Satto (31 yrs) s/o- Lt. Gopal Das of near Jagatbandhu Ashram Road, Netaji Colony, ward no-37, PO- Goghomali, PS- Bhaktinagar, dist- Jalpaiguri (ii) Palash Mandal (32 yrs) s/o Lt. Pujan Mandal of Shantinagar Sporting Club Road, ward no-36, PS- Bhaktinagar, dist- Jalpaiguri and (iii) Subhankar Paul @ Bhula (25 yrs) s/o Sambhu Paul of Amtala near Uttar Bangha Sambad, PO- goghomali, PS- Bhaktinagar, dist- Jalpaiguri and others and arrange for its investigation.
