I, Sribash Sarkar, son of Sunil Sarkar, residing at VidyaChakracolony, Ward No. 44, Ps, Bhaktinagar Dist, Jalpaiguri hereby inform you that My son, namely. Subhodeep Sarkar the Age about (17 Years) yesterday, on February 7, 2026, at approximately 8:30 PM, I received a phone call on my mobile phone. My son's friend, Pritam, called me and said that my son was in a critical condition and that I should come quickly, as he had been admitted to Navjeevan Health Care. Upon hearing this, I rushed there and learned this from my son that the Person named Ashish, who lives in Siliguri Gurung Busty Another person, namely. Rohan Lives in. Dangi Para Area. along with 20-25 other boys, had Attacked with Iron rod blade Knife. And tried to kill my son. The boy named Ashish called my son and summoned him to a place behind Surya Sen Park Siliguri There, they all severely beat With fist and blow him, and Ashish even inserted an iron punch into my son's head. My son was left lying there in a critical condition. Some local boys and other local people rescued him, and then he was taken to the nursing home. Currently, my son is unconscious, and he has received stitches on his head And more injuries in his body My son's friend, Rupom Biswas, further explained to me that this boy Ashish had repeatedly called my son and threatened to kill him if he didn't come. My son, out of fear, went there. Moreover. My son has his madhyamik exams. From Monday, but now he is fighting for His life.

Therefore, I humbly request that you investigate this matter and take appropriate legal action. I shall be obliged to you for this.
