Subject: Complaint for registration of FIR under Bharatiya Nyaya Sanhita, 2023 and request
for immediate arrest of the accused

Respected Sir,

I, Shamim Siddiqui, son of late Sharif Siddiqui, aged 47 years, resident of Masjidpara, Airport
More, ~~Bagdogra, Darjeeling~~ District, West Bengal, respectfully submit this complaint for
registration of a First Information Report (FIR) for serious cognizable offences committed
against me.

On 27 January 2026, at approximately 11:50 AM, I was supervising my construction site
situated at Nimtala, Near Aurum Hotel, Uttora By-Lane, Asian Highway. At that time, Mr.
Wajud Alam, son of late Manjur Khan, aged 38 years resident of Airport More, Bagdogra,
Mobile Number: 9832369669, along with his brothers Shahbaj Alam and Maksud Alam, and
one another unidentified person unlawfully entered my construction site without
permission.

Without any provocation or lawful justification, he started abusing me and making false
allegations of fraud, and suddenly assaulted me violently. He kicked me forcefully, due to
which I fell on the ground, and thereafter kicked me on my chest, causing visible bruises,
severe chest pain, and physical injury.

While I was lying on the ground and unable to defend myself, the accused picked up a piece
of TMT steel rebar and attempted to stab and impale me, clearly showing his intention to kill
me. Only due to the timely intervention of a labourer present at the site, my life was saved.
Had there been no intervention, the accused would have murdered me.

Immediately after the incident, due to persistent chest pain and injury, I visited the
Emergency Care Department of Bagdogra Government Hospital. The attending medical
officer examined me and stated that the injury is significant, advised multiple medical tests,
and provided treatment accordingly. I am attaching copies of the medical consultation
papers, test advice, and receipts in support of this complaint.

The entire incident is captured on CCTV cameras, and the footage clearly shows the unlawful
entry, physical assault, kicking, and attempted use of a lethal weapon. Several independent
eyewitnesses are also present who can corroborate the incident.

Before and after the incident, the accused has been openly threatening in the locality,
threatening traders, my business partners, contractors, and other persons, and stating that

he will murder me. He is also defaming me everywhere by spreading false statements accusing me of fraud, thereby damaging my reputation and livelihood. Due to these acts, I am living under constant fear for my life and safety.

The acts of the accused disclose commission of serious offences under the Bharatiya Nyaya Sanhita, 2023, including but not limited to Sections 109, 115, 118, 126, 127, 129, 329, 356, and 51, and other relevant provisions as may be attracted upon investigation.


In view of the gravity of the offence, the clear intention to murder, the medical confirmation of injury, and the continuing threats, I respectfully request you to:

1. Register an FIR immediately against the accused under the relevant provisions of the Bharatiya Nyaya Sanhita, 2023.
2. Arrest the accused forthwith, as his remaining at large poses an imminent and serious threat to my life and there is a real likelihood of repetition of the offence.
3. Take necessary steps to collect CCTV footage, record witness statements, and ensure my safety.

I am ready to cooperate fully and to provide CCTV footage, medical records, test receipts, and details of witnesses as required.

Kindly take immediate action in the interest of justice.
