**SUBJECT: WRITTEN INTIMATION**


Sir,

It is pertinent to mention here that there was some construction work going on and for the same some construction materials were lying in the said premises of Surendra Institute of Engineering and Management, Siliguri. The materials consisted of 16 mm 18 piece iron rods and 8 mm 20 piece iron rods worth Rs.22000/- But, i.e. on 06.02.2026 while checking the materials I was astonished to find that the above mentioned iron rods are missing from the site and the same was stolen from there. The matter is serious in nature and needs immediate attention as the matter involves loss of construction material.


I, therefore, request you to look into the matter at the earliest and take necessary action against the actual offender and book the culprit in accordance with appropriate provisions of law.
