Sir,

In producing herewith 02(Two) accused person namely i) Biren Sarkar of Rana Nagar, VTC, Matapari PS- Matigara, Dist- Darjeeling ii) Gurudas Roy (M/25) S/O- Prafulla Roy of Rabindra Nagar, Patiramjote, PS- Matigara, Dist- Darjeeling along with seized 02(TWO) vehicle displaying Reg. No. WB 73 C 3316 and WB 73 C 3842 loaded with riverbed materials, I ASI Mangal Kisku of Matigara P.S, SPC do hereby lodge a Complaint against the above noted accused persons to the effect that on 08.02.2026 at 13:55 hrs, during K-33 Morning van duty vide MCC NO- 361/26 dated- 08/02/2026 along with force received an information from reliable source that 02 (Two) EICHER and SML Truck displaying Reg. No. WB 73 C 3316 and WB 73 C 3842 loaded with illegal riverbed materials is coming from Nabajyoti Club more towards Matigara Bypass More. This refers to Matigara PS GDE No- 480, Dt- 08.02.2026. On receiving the information I along with force rushed to the spot to work out the information. Under information and kind order of I/C Matigara P.S on arrival at Matigara Bypass More, Near Biswas Colony under Matigara P.S Dist- Darjeeling, I found said vehicles displaying Reg. No- WB 73 C 3316 and WB 73 C 3842 loaded with riverbed materials is coming towards Matigara Bypass More. Subsequently, I managed to stop the vehicle at Matigara Bypass More, Near Biswas Colony under Matigara P.S Dist- Darjeeling. The drivers of these vehicles disclosed their names and addresses as noted above. I asked the driver to produce valid documents / papers of the said riverbed materials but they were unable to produce any valid documents/ papers of the said riverbed materials. There was a sufficient reason to believe that the above noted accused drivers of above noted vehicles had procured the riverbed materials illegally without any proper royalty/ papers as per rule, for selling clandestinely for their wrongful gain. Accordingly, I seized the above noted 02 (Two) EICHER and SML Truck displaying Reg. No. WB 73 C 3316 and WB 73 C 3842 loaded with illegal riverbed materials under proper seizure list and brought the above noted vehicles at P.S. The whole process of search & seizure was made on 08.02.2026 in between 14:42 hrs to 14:55 hrs. The whole process of seizure was made under videography through WB E-Sakshya application.

Therefore I pray before you a specific case may kindly be started against the drivers of the vehicles namely i) Biren Sarkar(M/34) S/O- Sushil Sarkar of Rana Nagar, VTC, Matapari , PS- Matigara, Dist- Darjeeling ii) Gurudas Roy(M/29) S/O- Prafulla Roy of Rabindra Nagar, Patiramjote, PS- Matigara, Dist- Darjeeling and the seized vehicle bearing Reg. No- WB 73 C 3316 and WB 73 C 3842 under proper section of law and arrange for its investigation.
