**Incident Details:**

On 05 February 2026, at around 10:30 PM, my son Sajahan Siraj met with a serious road accident near Agarwal Bhawan, Kawakhali, close to North Bengal Medical College and Hospital. At the time of the incident, he was delivering an active Zomato order from SF Road, Maharaja Restaurant to Rangapani IOCL. An unknown truck hit his vehicle from behind with great force. After causing the accident, the driver fled from the spot without providing any help. Local people rushed my son to North Bengal Medical College and Hospital.

Despite medical intervention, the attending government doctor declared him dead on 05 February 2026. On 06 February 2026, his body was sent for post-mortem examination in connection with Matigara Police Station U.D. Case No. 151/26 dated 06 February 2026.

**Cause of Complaint:**

The accident occurred due to rash and negligent driving of the unknown truck driver who escaped from the spot, causing the untimely death of my son. Due to funeral rituals, this complaint is being filed today without intentional delay.

I respectfully request you to register an FIR against the unknown truck driver and conduct investigation with utmost urgency.
