SUBJECT - INFORMATION REGARDING ACCIDENTAL DEATH
OF MY ELDER BROTHER.

Respected Sir / Madam,

I Sheshan Dan Adhikari, s/o Daniel Adhikari, resident of N 0085, Sherpa Bagan - Paschim, Echley Khasmahal, Kalimpong 734317, would like to inform you about the accidental death of my brother date Clement Mark Adhikari. On 24/06/2025 at about 1:30am, my brother date Clement Mark Adhikari age 32 was riding his motorcycle bearing registration number WB79A9513 on Salugara CNH10. Due to collision with domestic cattle (Bull). He met with a serious road accident.

He sustained severe injuries and was immediately taken to siliguri District Hospital, near Court More, where the doctor declared him dead during arrival.

The death appeared to be purely accidental, we did not file a FIR as we didn't know that FIR will be required when the Insurance Company Policy, and we did not know who was the owner of that domestic cattle (Bull). As in that situation ^{we} were not able to put rightful decision. The delay of FIR was proceeded.

I kindly request you to please register this information conduct the necessary legal procedure, and take further action as per law.

I am ready to cooperate fully with the investigation.
