Sir,

In producing herewith arrested accused person namely Premlal Roy (72 yrs) S/O Late Pada Charan Roy of Simulguri, Uttar Saman Nagar, PS- Bhaktinagar Dist- jalpaiguri along with seized articles vize i) 03(three) sealed bottles of Himalayan Gold 60 up Country Spirit containing 600 ml each , amounting of Rs.170/- each, marked as Exhibits- A, ii) 01(one) sealed bottles of Himalayan Gold 60 up Country Spirit containing 600 ml each was taken up from exhibit -A as sample for a examination, marked as Exhibits- A1, iii) 02 (two) sealed bottles of Blenders Pride whiskey ultra Premium containing 750 ml each , amounting of Rs 540/- each, marked as Exhibits-B, iv) 01 (one) sealed bottle of Blenders Pride whiskey ultra Premium containing 750 ml was taken out from Exhibits-B as sample for examination, marked as exhibits-B1, v) 02 (two) sealed bottles of McDowel No1 Luxury blended whiskey containing 750 ml each , amounting of Rs 710/- each, marked as Exhibits-c, vi) 01 (one) sealed bottles of McDowel No1 Luxury blended whiskey containing 750 ml was taken out from exhibits C as sample for examination , marked as Exhibits-C1, vii) 02 (two) sealed bottles of Old Monk XXX Rum containing 750 ml each , amounting of Rs 620/- each, marked as Exhibits-D, viii) 01 (one) sealed bottles of Old Monk XXX Rum containing 750 ml was taken out from Exhibits D as sample for examination, marked as Exhibits-D1, ix) 02 (two) sealed bottles of Hayward DS Bold strong Beer containing 650 ml each , marked as Exhibits-E, x) 01 (one) sealed bottle of Hayward DS Bold strong Beer containing 650 ml each, marked as Exhibits-E1 as per seizure list.

I, ASI Dipak Karmokar of Bhaktinagar PS, SPC do here by lodged a written complaint against above noted arrested accused person namely Premlal Roy (72 yrs) S/O Late Pada Charan Roy of Simulguri, Uttar Saman Nagar, PS- Bhaktinagar Dist- jalpaiguri to the effect that on 09.02.26 at 12.45 hrs acting on secret source information that the above noted person was busy to sale foreign and Id liquor illegally in his house situated at Simulguri, Uttar Saman Nagar under PS- Bhaktinagar Dist- Jalpaiguri in order to clandestinely dispose the same. Accordingly the fact is diarized in GD vide Bhaktinagar PS GDE no.465 dated 09.02.26 and informed the fact to I/C Bhaktinagar PS. As per direction of I/C Bhaktinagar PS, I along with ASI Dhruva Mishra , C/374 Debraj Biswas both of Bhaktinagar PS left for Simulguri, Uttar Saman Nagar, PS- Bhaktinagar, Dist- Jalpaiguri to verify the veracity of the information vide Bhaktinagar PS G.D.E No.466 dated 09.02.26. On reaching at 13.55 hrs at the mentioned P.O and as identified by source cordoned the above noted area where he was selling illegal alcohol. On seeing the police party the above noted person tried to escape from the spot but we managed to apprehend the above noted person and on interrogation, he disclosed his identity as noted above. On being asked he stated that he used to sale the foreign liquor and I/D liquor to his design customer at his locality without any valid documents. On being asked he could not produce any valid documents in respect of the said liquor. On searching i)

03(three) sealed bottles of Himalayan Gold 60 up Country Spirit containing 600 ml each , amounting of Rs.170/- each, marked as Exhibits- A, ii) 01(one) sealed bottles of Himalayan Gold 60 up Country Spirit containing 600 ml each was taken up from exhibit –A as sample for a examination, marked as Exhibits- A1, iii) 02 (two) sealed bottles of Blenders Pride whiskey ultra Premium containing 750 ml each , amounting of Rs 540/- each, marked as Exhibits-B, iv) 01 (one) sealed bottle of Blenders Pride whiskey ultra Premium containing 750 ml was taken out from Exhibits-B as sample for examination, marked as exhibits-B1, v) 02 (two) sealed bottles of McDowel No1 Luxury blended whiskey containing 750 ml each , amounting of Rs 710/- each, marked as Exhibits-c, vi) 01 (one) sealed bottles of McDowel No1 Luxury blended whiskey containing 750 ml was taken out from exhibits C as sample for examination , marked as Exhibits-C1, vii) 02 (two) sealed bottles of Old Monk XXX Rum containing 750 ml each , amounting of Rs 620/- each, marked as Exhibits-D, viii) 01 (one) sealed bottles of Old Monk XXX Rum containing 750 ml was taken out from Exhibits D as sample for examination, marked as Exhibits-D1, ix) 02 (two) sealed bottles of Hayward DS Bold strong Beer containing 650 ml each , marked as Exhibits-E, x) 01 (one) sealed bottle of Hayward DS Bold strong Beer containing 650 ml each, marked as Exhibits-E1 and accordingly I seized the same as per seizure list as he has violated the norms of Bengal Excise Act for selling the said seized articles without any valid license. He also stated that he is doing this liquor business since long for his wrongful gain. Accordingly I seized the same in presence of witness duly signed by them. The seizure and label was made in between 15.55 hrs and 16.55 hrs. As such I arrested him U/S-35(1) BNSS after observing all sort of rules after mainlining her decency.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused person namely Premlal Roy (72 yrs) S/O Late Pada Charan Roy of Simulguri, Uttar Saman Nagar, PS- Bhaktinagar Dist- Jalpaiguri along with seized articles under proper section of law and arrange for its investigate.
