Sir,

In producing herewith the following seized article i.e. one tractor displaying No. WB/TC-164 loaded with full trolley river bed materials (RBM) along with its ignition key under proper seizure memo and I, ASI Nikesh Chettri of Bagdogra PS, SPC, do hereby lodge this written complaint against the driver of the above noted tractor displaying No. WB/TC-164 to the effect that today on 07.02.2026 morning I along with C/851 Chandan Debnath & C/1160 Bhajan Sarkar had been performing scheduled K-36 mobile van duty under Bagdogra PS jurisdiction vide Bagdogra PS GDE No. 288 dated 07.02.2026 and E-Khaki CC No. 415/26 dated 07.02.2026. At around 13:45 hrs, in course of performing mobile van duty, I received reliable source information that one tractor loaded with full trolley river bed materials (RBM) without obtaining valid document viz. royalty paper etc. and deceiving Government revenue has been coming from Gossainpur side through the service road of AH-02 and proceeding towards Bagdogra Bihar more side. Accordingly, I informed the matter to O/C Bagdogra PS and left for Bagdogra Station more by Govt. vehicle No. WB77/4082 to work out the veracity of the source information. At around 13:55 hrs we reached at Bagdogra Station more under Bagdogra PS and made an ambush there. After a while at around 14:05 hrs the source indicated & identified the tractor. Accordingly, we gave signal to the driver to stop the said tractor. Seeing the Police personnel, the driver of that tractor fled away from the spot keeping the tractor on the road. We tried to apprehend the suspect driver but could not detain him. Then, I searched the tractor in presence of the Police personnel. On search, river bed materials (RBM) was found inside the trolley of that tractor displaying No. WB/TC-164. I waited there but none came forward claiming that tractor. There is every suspicion that the driver of that tractor had procured river bed materials (RBM) and loaded on the trolley of the tractor displaying No. WB/TC-164 without obtaining valid document viz. royalty paper etc. and thus deceiving Government revenue. At last, I recovered the tractor displaying No. WB/TC-164 loaded with full trolley river bed materials (RBM) along with its ignition key which is supposed to be a stolen property and seized the same under proper seizure list as 'Stolen Recovered' property from the PO. The process of search & seizure is done in between 14:05 hrs & 14:20 hrs on 07.02.2026 through audio-video electronic means using Govt. mobile App 'WB E-Shakshya' vide Evidence Certificate Nos. C-288-50536-20260207141826, C-288-50537-20260207141914 & C-288-50540-20260207142603.

Under the above facts & circumstances, I request you to initiate a specific case under proper sections of law against the involved driver of the tractor displaying No. WB/TC-164 and arrange for its investigation.
