Dear Sir,

With due respect, I the undersigned would like to inform you that Anil Kumar Mitruka, son of Brij Mohan Mitruka is my brother, Sarita Devi Mitruka, wife of Anil Kumar Mitruka is my sister-in-law, Sourav Mitruka and Sachin Mitruka are the sons of Anil Kumar Mitruka. I am Chartered Accountant by profession having my office situated at 146, M.G. Road, Khalpara, Ward No. 9 of Siliguri Municipal Corporation, Post Office and Police Station - Siliguri.

I would like to further inform you that I am a patient of High Blood pressure and I also have a severe breathing problem for which I use C-PAP (Continuous Positive Airway Pressure) Machine as per the aid and advice of the doctor.

I would like to further inform you that due to the illegal activities as committed by said Anil Kumar Mitruka alongwith his said wife and son Sourav Mitruka in respect of the partnership firm 'M/s Biswanath Champalal', I lodged complaint with the Commissioner of Police, Siliguri Police Commissionerate on 19.04.2025 but due to inaction, I was compelled to file an application under Section 173(4) r/w Section 175(3) of BNSS, 2023 before Learned Additional Chief Judicial Magistrate, Siliguri being Misc. Petition No. 29/2025 levelling allegations regarding their illegal activities and after hearing the Learned Court vide its order dated 21.05.2025 was pleased to direct the Inspector In-Charge, Siliguri Police Station to cause investigation into the said allegation after treating the said application as FIR.

I would like to further inform you that in compliance with the said direction, Inspector In-Charge, Siliguri Police Station was pleased to register a specific case against said Anil Kumar Mitruka, Sarita Devi Mitruka and their son Sourav Mitruka being Siliguri P.S. Case No. 580/2025 dated 01.09.2025 u/s 126(2)/115(2)/316(2)/318(2)/331(1)/336(3)/338/339/340(2)/74/351(2)/61(2) of B.N.S, 2023.

I would like to further inform you that apart from above, said Anil Kumar Mitruka also committed gross illegal activities in respect of another partnership firm 'M/s Bhawani Plantation', I tried to lodge complaint with the law enforcement agencies but due to their inaction, I was again compelled to file an application under Section 173(4) r/w Section 175(3) of BNSS, 2023 before Learned Additional Chief Judicial Magistrate, Siliguri being Misc. Petition No. 40/2025 levelling allegations

I would like to further inform you that in compliance with the said direction, Inspector In-Charge, Siliguri Police Station was pleased to register a specific case against said Anil Kumar Mitruka and another co-accused Prem Prakash Mitruka being Siliguri P.S. Case No. 753/2025 dated 18.11.2025 u/s 318(2)/318(4)/319(2)/316(2)/336/338/341/118/3(2) of B.N.S, 2023.

I would like to further inform you that after the registration of the aforesaid criminal case, said Anil Kumar Mitruka, his wife Sarita Devi Mitruka and his sons Sourav Mitruka and Sachin Mitruka started creating immense pressure upon me and my family to withdraw both the cases by hurling foul slangs and abusing me and my family on frequent basis and Sachin Mitruka has threatened me of dire consequences on several occasions that if I do not withdraw the said complaints lodged against his family members, he will give me a remarkable lesson in front of the entire locality.

I would like to further inform you that today nearly about quarter to 5 p.m., while I was working in my office, out of a sudden, said Sachin Mitruka alongwith his brother Sourav Mitruka, Anil Mitruka and Sarita Devi Mitruka alongwith their staff Pradip, Ajay and Raj alongwith 5(five) number of unknown miscreants who were their arranged muscle men gathered in front of my said office and before I could get any hint of attack upon me, said Sachin Mitruka kicked the door of my said office and after getting inside, rushed towards me and without affording me anytime to protect myself, he knowing fully that I have a breathing problem, tightly pressed my throat with his both the hands to kill me and due to the choking I was almost on the verge of unconsciousness and I fell down on the floor. Thereafter said Sachin Mitruka, Sourav Mitruka and their staff Pradip, Ajay and Raj alongwith other miscreants dragged me outside my office premises and all of them started to kick me and fist blows entire over my body particularly on my chest. Sachin Mitruka also attacked upon me with a sharp object for which I suffered a cut over my forehead. When my son Keshav Mitruka came to the rescue, they also hit my son with fist blows and kicks. My wife Shalini Mitruka came to the rescue but she was abused by them in most filthy languages. They threw my computer parts, vital files alongwith containers, car accessories and documents kept inside the office alongwith drums and stuffs kept in my godown adjacent to my office on road and in drain outside. Somehow, I and my son were rescued by the local people and I was treated at Siliguri District Hospital.

I would like to further inform you that said Sachin Mitruka, his brother Sourav Mitruka and Pradip, Ajay and Raj alongwith other miscreants before leaving the said premises, threatened me and my family of dire consequences that if we wish to survive, we must withdraw the afore-mentioned cases, otherwise they will get me and my entire family murdered.

Under the above-circumstances, I would like to request you to lodge an FIR against the said accused persons and save me and my family from the said accused persons for the ends of justice.
