In producing herewith two arrested accused persons namely (1) Sudesh Rajak (M/31) S/O Chandan Rajak of Netaji Nagar, Backside of State Guest House, PS- Pradhannagar, Dist- Darjeeling and (2) Sudipto Pandit (M/38) S/O Late Anil Kumar Pandit of Baghajatin Colony, Ward No. 2, Road No. 2/1, PS- Pradhannagar, Dist- Darjeeling along with the following seized articles under seizure as per seizure list:

- [1] 01 (one) Cardboard made Carton containing 42 numbers of small packets of Nitrazepam Tablets I.P. 10 mg (Nitcor-10), each packets containing 6 strips , each strips containing 50 tablets, Total (42 X 6 X 50) = 12600 Tablets, manufactured by Veritas Health Science Pvt. Ltd. Batch No. T 19601.
- [2] One Red & Black coloured TOTO van bearing No. WB 73F-8088
- [3] One blue coloured POCO C50 mobile phone bearing IMEI No. 860801062669007 & 860801062669015
- [4] One black coloured key Pad phone (Karbonn) bearing IMEI No. 354542510190062 & 354542510190070.

I, SI Biswajit Ghosh of DD, SPC do hereby lodged this written complaint against above mentioned two accused persons and one other to the effect that today 06.02.2026 at about 16.05 hrs I received a specific source input that today afternoon , above mentioned two persons will carry huge quantity of tablets without any document from Siliguri Bus Terminus area and will proceed towards Pradhannagar area for delivering the same to their designated customers for their wrongful gain. The matter was diarized in DD, SPC GDE No. 29, Dtd- 06.02.2026 and subsequently, I informed the matter to the ACP, DD, SPC and being directed, at 16.15 hrs myself along with SI Basudeb Guha, SI Krishna Parja, ASI Sushanta Dey, Const-670 Ratan Roy and Const-813 Gyanendra Ch. Sarkar all of DD, SPC left for Siliguri Bus Terminus area under pradhannagar PS with govt. vehicle along with investigation kit to verify the veracity of the information vide DD, SPC GDE no. 30 , Dt- 06.02.2026 and M.C.C No- 41/2026 Date- 06.02.2026.

After reaching at Siliguri Bus Terminus, I requested two available independent witnesses namely (1) Sanjay Singh (M/43, Ph- 9832080445) S/O Late Laxmi Singh of Patiramjote near Radha Krishna Mandir, PS- Matigara, Dist- Darjeeling and (2) Chhabila Gupta (M/45, Ph- 8578888655) S/O Late Gyajendra Gupta of Tumbajote near Radha Krishna Mandir, PS- Matigara, Dist- Darjeeling in written to remain present as witness during search and seizure if any. They gave their willingness and accompanied with us.

Thereafter at about 16.40 hrs we reached at backside of Siliguri Junction near Private Bus Terminus and as shown by the source we cordoned a specific place behind junction . At about 16.45 hrs on being pointed by source we found two persons boarded on a TOTO loaded with one cardboard made carton and accordingly we detained them. We disclosed our identity and on question they disclosed their name and address as above. We also disclosed them about the information in hand. On interrogation they confessed that they procured contraband tablets illegally without any documents and will sell the same at Siliguri for their wrongful gain . They also stated that one Bappa of Baghajatin Colony, Ward No. 45, Road No. 45/6, PS- Pradhannagar, Dist- Darjeeling

(Ph. No. 78640078798 and 9002478718) is also involved in procuring contraband tablets illegally and as per his direction they collected the same to supply to the designated customers for their wrongful gain. I gave them option in writing whether they wanted to be searched in presence of a Magistrate or in presence of a Gazetted Officer. They gave their consent for search in presence of any of them.

Accordingly, I informed the matter ACP DD, SPC and as per his direction, informed Sri Kajal Sarkar, Inspector of Police, DD, SPC regarding the interception of the accused persons possessed contraband tablets and requested him to come at backside Siliguri Junction near Private Bus Terminus under Pradhannagar PS to remain present and to supervise the search and seizure .

Accordingly at 17.20 hrs Sri Kajal Sarkar, Inspector of Police, DD, SPC arrived at the spot and subsequently, under his supervision, in presence of witnesses the process of search of the detained persons were conducted following all formalities and recovered the above mentioned articles. Subsequently, being demanded in presence of Sri Kajal Sarkar, Inspector of Police, DD, SPC the detained persons failed to produce any valid document in support of possessing of such quantity of Nitrazepam Tablets. Accordingly , I seized and labelled the same from the exclusive and conscious possession of above noted accused persons at the spot under proper seizure list under videography and duly signed by above noted witnesses and the Gazetted officer and acknowledged by the accused persons. The whole process of seizure was made in between 17.25 hrs and 17.50 hrs on 06.02.2026. Then, I arrested the above noted accused persons after observing all formalities and informing the ground of their arrest and issued necessary Memo of Arrest.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused persons are involved in procuring and selling of contraband drugs illegally contravening the norms of NDPS Act.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person namely (1) Sudesh Rajak (M/31) S/O Chandan Rajak of Netaji Nagar, Backside of State Guest House, PS- Pradhannagar, Dist- Darjeeling , (2) Sudipto Pandit (M/38) S/O Late Anil Kumar Pandit of Baghajatin Colony, Ward No. 2, Road No. 2/1, PS- Pradhannagar, Dist- Darjeeling and (3) Bappa of Baghajatin Colony, Ward No. 45, Road No. 45/6, PS- Pradhannagar, Dist- Darjeeling (Ph. No. 78640078798 and 9002478718)and arrange for its investigation.
