Sir,

With due respect, I am producing herewith two(02) accused persons namely (i) Dina Kumar(22yrs) S/O Upendra Mahato and (ii) Sourabh Kumar (21yrs) S/O Kamlesh Kumar Singh both are residence of Minapur, Mankar, PS Minapur, Dist Muzaffarpur, Bihar, under arrest under arrest and the following articles under proper seizure list viz :-

1. One black colour back pack containing 24 bottles of KINGFISHER STRONG PREMIUM BEER, each bottle contains 500ml. i.e. total (24x500ml= 12ltr), and marked as Exhibit "A" out of which one bottle of same taken as sample for examination and marked as exhibit "A1".
2. One Red colour bag containing 24 bottles of KINGFISHER STRONG PREMIUM BEER, each bottle contains 500ml. i.e. total (24x500ml= 12ltr), and marked as Exhibit "B" out of which one bottle of same taken as sample for examination and marked as exhibit "B1".
3. One Purple colour bag containing 32 bottles of KINGFISHER STRONG PREMIUM BEER, each bottle contains 500ml. i.e. total (32x500ml= 16ltr), and marked as Exhibit "C" out of which one bottle of same taken as sample for examination and marked as exhibit "C1".
4. One black colour back pack containing 08 bottles of "MAGIC MOMENTS GRAIN VODKA", each bottle contains 750ml. i.e. total (08X750ml= 6ltr), and marked as Exhibit "D" out of which one bottle of same taken as sample for examination and marked as exhibit "D1".

I ASI Bikash Roy of Pradhan Nagar PS, SPC do hereby lodged this written complaint against the above mentioned two arrested accused persons namely (i) Dina Kumar(22yrs) S/O Upendra Mahato and (ii) Sourabh Kumar (21yrs) S/O Kamlesh Kumar Singh both are residence of Minapur, Mankar, PS Minapur, Dist Muzaffarpur, Bihar to the effect that on 08.02.2026 at about 19:45hrs, I received specific secret information that two persons carrying and possessing a huge quantity of illicit liquor was standing in front of Siliguri Junction traffic Bit office, Siliguri Junction, under P.S. Pradhan Nagar, and was waiting for a bus to transport the same to Bihar for their wrongful gain.

The said information was duly entered in the General Diary of Pradhan Nagar P.S. vide GDE No. 487 dated 08.02.2026, and the matter was intimated to you. As per your kind order and direction, I along with force proceeded to the spot by government vehicle with investigation kit to verify the veracity of the information.

At about 20:00 hours, we reached in front of Siliguri Junction traffic Bit office, Siliguri Junction. On being pointed out by the source, we noticed two persons standing with a bags. The above named persons were detained, and our identities as police personnel were disclosed to them. Upon interrogation, they disclosed their identity, as mentioned above.

On search, (i) One black colour back pack containing 24 bottles of KINGFISHER STRONG PREMIUM BEER, each bottle contains 500ml. i.e. total (24x500ml= 12ltr), and marked as Exhibit "A", (ii) One Red colour bag containing 24 bottles of KINGFISHER STRONG PREMIUM BEER, each bottle contains 500ml. i.e. total (24x500ml= 12ltr), and marked as Exhibit "B", (iii) One Purple colour bag containing 32 bottles of KINGFISHER STRONG PREMIUM BEER, each bottle contains 500ml. i.e. total (32x500ml= 16ltr), and marked as Exhibit "C" and (iv) One black colour back pack containing 08 bottles of "MAGIC MOMENTS GRAIN VODKA", each bottle contains 750ml. i.e. total (08X750ml= 6ltr), and marked as Exhibit "D". The accused persons failed to produce any valid licence or documents in respect of the recovered liquor. Accordingly, the recovered liquor was seized under proper seizure list in presence of independent witnesses with videography, as per the norms of BNSS. The entire process of search, seizure, and labelling was conducted under videographic coverage between 20:25 hours and 21:20 hours at the spot.

During interrogation, the accused persons admitted that they were transporting the illicit liquor to Bihar for selling the same at a higher price without any valid licence or permission and that they had been engaged in such illegal activities for a long time for their wrongful gain. Accordingly I arrested the accused persons following all legal formalities, informed of the grounds of arrest both verbally and in writing, and brought to Pradhan Nagar Police Station for further legal action.

Hence the accused persons namely (i) Dina Kumar(22yrs) S/O Upendra Mahato and (ii) Sourabh Kumar (21yrs) S/O Kamlesh Kumar Singh both are residence of Minapur, Mankar, PS Minapur, Dist Muzaffarpur, Bihar, has violated the norms of Bengal Excise Act. Therefore, I pray before your good self that a specific case may kindly be initiated against the arrested accused persons namely (i) Dina Kumar (22yrs) S/O Upendra Mahato and (ii) Sourabh Kumar (21yrs) S/O Kamlesh Kumar Singh both are residence of Minapur, Mankar, PS Minapur, Dist Muzaffarpur, Bihar, under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
