Respected Sir / Madam,

I Shiv Hazra, son of Lt. Gopal Ch. Hazra, resident of Narmada Bagan, Champasari, Gliguri, writing this letter to bring your kind attention the serious problem caused by a physically assaulted at upper pokrajok. The accused, name Sankar Dutta, son of Nirmal Dutta, took money from me in the name of purchasing land. Both of them personally met me and collected the amount from me. However, for many years they have been deliberately misleading me, and continuously delaying the matter with dishonest intention. The father (Nirmal Dutta) and son (Sankar Dutta) together collected money from me. On today's date, when I demanded the return of my money, Sankar Dutta used abusive and threatening language, insulted me and told me to take money from his father. Their conduct was deliberate and meant to harass me, which caused the dispute to escalate.

Therefore, Sankar Dutta and his son Sumit Dutta (Tiko) along with his associates criminally assaulted me. They dragged me on the ground, pushed me repeatedly, beat me severely, and threatened me with serious consequence. I suffered physical injuries, mental trauma, and humiliation, and my life and personal safety were put in grave danger.

The accused persons acted with criminal intent to cheat, intimidate, and cause bodily harm. All this physical assault was committed by his son (Sumit Dutta) while under the influence of alcohol. Their actions amount to serious offence under Law.


I therefore, humbly request you to register an FIR and take strict legal action against all the accused persons at the earliest to ensure justice and protect my safety.
