**Subject: Formal Complaint Regarding Criminal Intimidation, Attempted Assault, Forced Admission and Apology Under Coercion, False Accusations, Threat to Life, and Harassment at Government Medical Sub-Centre**

Respected Sir/Madam,

I, **Sangay Lamu Bhutia**, am working as a healthcare staff member at the Government Medical Sub-Centre located at Salbari Sub-Centre. I am writing to lodge a formal complaint regarding serious incidents involving criminal intimidation, attempted assault, forced admission and apology under coercion, false accusations, threats to life, pressure to administer vaccination illegally, and continued threats against my family and me.

### **First Incident – 4th February (Wednesday)**

On **4th February (Wednesday)**, a couple came to the sub-centre requesting vaccination for their child.

As per the Government of India vaccination protocol and medical safety guidelines, vaccination cannot be administered without verifying the child's vaccination card or official immunization record. The couple informed me that they had forgotten or lost the vaccination card.

I clearly and politely refused to administer vaccination without documentation, as doing so would be against government medical rules, unsafe for the child, and illegal from a professional standpoint. I strictly followed official protocol and **did NOT administer any vaccination**.

During the conversation, there was pressure on me to give the vaccination despite the lack of documents.

At that time, I was having an internal discussion with my staff regarding record management and statistical patterns seen in our working area related to lost vaccination cards. During this internal staff discussion, I mentioned that in our working area, during calculations and record review, many cases of lost vaccination cards had been reported among certain groups, including many people from Bihar. This discussion was part of internal statistical and record analysis only and was **not directed at the couple or any individual patient**, and was **not intended as a racial or discriminatory remark**.

It appears that they overheard the word "Bihari" and later falsely accused me of making racial comments against them.

### **Second Incident – 6th February**

On **6th February**, **Lalan Yadav from Salbari** came to the sub-centre along with approximately **six adult men**.

They entered the sub-centre premises in an aggressive and hostile manner. They started verbally abusing me, intimidating me, and **attempted to physically attack me inside the government medical facility**. I was outnumbered and feared serious harm and danger to my life.

I believe I was also targeted and victimized because I am a physically small woman and was alone at the workplace at that time.

During this incident, they:

- Threatened to **burn the medical sub-centre building with me inside**
- Forced me to **provide my residential home address** with malicious intention
- Tried to force me to **illegally administer vaccination** to their child even though I had already refused and followed protocol
- Created fear, panic, and disruption inside a government healthcare facility
- **Forced me to falsely admit and apologize for alleged racial comments**, which I had not made

During the confrontation, one of the male individuals stated that **his wife could not have forced me to give a vaccination because they are "highly educated" and respected in society**, while at the same time threatening and intimidating me.

They forced me to admit to making racial comments and apologize to them, which is completely false. I had only spoken internally to my staff about statistical observations regarding record trends. They overheard the word "Bihari" and became aggressive.

I was forced to make this admission and apology only because I was surrounded by multiple aggressive individuals and feared physical harm and danger to my life. This admission and apology were made under **fear, pressure, and coercion**, and were not voluntary.

They also stated that they would **organize signatures and file a petition among members of the Bihari community and submit complaints to the District Magistrate (DM)** against me in order to create pressure and harassment.

---

### Fear for Safety

Due to these incidents and threats, I am now living in fear for **my own safety as well as the safety of my children and family members**, especially because they forced me to disclose my residential address.

---

This entire incident is not only a personal attack on me but also an attack on a **Government Healthcare Institution** and the public healthcare service system.

I am a government healthcare worker serving the community honestly and strictly following medical and legal guidelines. I am mentally distressed and in fear of further harassment or attack.

---

### Request for Action

Therefore, I respectfully request you to:

1. Register an FIR under relevant IPC sections for criminal intimidation, unlawful assembly, attempted assault, threat to life, coercion, and obstruction of a government servant on duty.
2. Provide immediate protection to me and my family.
3. Take strict legal action against all persons involved in this incident.
4. Ensure safety and security measures for staff working in the medical sub-centre.

I am willing to fully cooperate with the investigation and can help identify the accused persons.

I request urgent action as I am in fear of further attack.
