with due respect I am Hema Roy (F/20yrs) W/O Rabindra Nath Roy resident of 1 no Panchanan colony, Diesel sporting club, ward no - 1, Siliguri, West Bengal, Darjeeling. would like to inform you that on 08/02/26 at around 9pm while I and my husband was watching volleyball tournament at Diesel sporting club ground at that time one man namely Bishal Roy comes beside my husband and ~~put~~ punches on my husband's face in front of all members. later when all the members present on the ground took him to the other side Bishal Roy called his family members and his friends then they all rushes to my house and forcefully entered the house and tore my clothes with wrong intention. Bishal Roy and 4 others mentioned above pushed me down and physically assaulted me and not let me get up. when my sister in law tried to help me at that time Santona Roy, Priyanka Roy, Lakhi Roy beats badly <sup>to</sup> my sister in law and catches her hair and pulled it later they all members threatened us with their consequence and uses abusing word. But how we all members escape from the situation with the help of our neighbours. when ~~we~~ we check our house I got to see that my husband has kept 6500 Rupees that was also missing from our house and one Android phone of pp A16E, Black color along with 2000 rupees on its back cover. Due to these incident we had to go Siliguri district hospital.

So, sir I request you to help us from them because all our family members are so much afraid of them; because they have threatened us that when ever they will see us outside they will again beats us.

Hence I pray before you may kindly consider my prayer and take a necessary step against them.
