Subject: Written Complaint regarding repeated threat, criminal intimidation, stalking, and attempt to abduct by **Deep Roy** (already FIR lodged)

Respected Sir,

I, **DISHA CHOWDHURY**, D/O Sri Swaraj Chowdhury, resident of New Pokajote, P.S. Pradhan Nagar, Siliguri, most respectfully submit this written complaint for your kind consideration and immediate legal action. That I had earlier lodged a written complaint and FIR at your Police Station against one **DEEP ROY**, S/O Dipen Roy, resident of Samar Nagar, P.S. Pradhan Nagar, Siliguri, being FIR No. Pradhan Nagar P.S. 478/2024, Dated 28/07/2024 Copies of the said complaint and FIR are Attached herewith, the said **DEEP ROY** has continued to harass, threaten, and follow me, showing complete disregard for the law.

That yesterday at about 4:30–5:00 PM, while I was waiting for a Toto near Tower Gali, Kadamtala, Champasari, after visiting my friend's house, the said **DEEP ROY** suddenly stopped me on the road, and forcibly tried to make me sit on his motorcycle and insisted that I go with him. I became extremely frightened and sensed immediate danger to my life.

That to save myself, I ran into a nearby grocery shop known as "Prasad Store" and informed the lady shopkeeper that the Said **DEEP ROY** was following me and forcing me to go with him.

That the said **DEEP ROY** followed me till the shop and openly threatened me in public, stating in Bengali "Ami kauke bhoi pai na", and further threatened that he would kidnap and kill me if I did not withdraw the case lodged against him, due to fear and panic, I somehow managed to escape from the spot with the help of a Rapido bike driver and safely reached my home. I was under severe mental shock and fear throughout the incident.

That I am living under constant fear for my life and safety, and the accused may cause serious harm to me at any moment if strict legal action is not taken immediately.

Therefore, I most humbly request you to Kindly Take immediate legal action against the Said **DEEP ROY** (Ph No. 75868 10329); ✓

I am ready and willing to cooperate with the investigation in every possible manner. I shall be highly obliged for your prompt and necessary action.
