Sir,

With due respect, I ASI Aibul Islam of Matigara P.S SPC would like to lodge this written complaint against (i) Bapi Mandal s/o Nikhil Mandal (ii) Subrata Biswas (iii) Robi Roy (iv) Debn Das (v) Babu (vi) Amit Bala (VII) Pralad Biswas (VIII) Mina Mandal (ix) Chumki Sarkar (x) Bapi Das (xi) Kajal Sarkar and others 60/70 persons to the effect that today i.e on 10.02.26 during my evening Mobile Van duty vide Matigara PS CC No-386/2026, Dated – 10.02.26 & vide Matigara PS GDE no. 598 Dated: 10.02.2026 received an information at about 17.05 hrs in the huge number of people put a huge road blocked on NH 31 C in front of Balason Traffic Gurad under P.S – Matigara, Dist. – Darjeeling. Accordingly, I along with my accompanied force had been to the said area and found that approx 70/80 persons under the leadership of above (i) Bapi Mandal s/o Nikhil Mandal (ii) Subrata Biswas (iii) Robi Roy (iv) Debn Das (v) Babu (vi) Amit Bala (VII) Pralad Biswas (VIII) Mina Mandal (ix) Chumki Sarkar (x) Bapi Das (xi) Kajal Sarkar and others 70/80 others have obstructed the NH 31 C in front of Balason Traffic Gurad under P.S – Matigara, Dist – Darjeeling, over the issue of alleged Murder of Sourab Modak. As a result Traffic movement on NH 31 C in front of Balason Traffic Gurad under P.S – Matigara, Dist – Darjeeling were totally stopped, around 200 vehicles towards four side at Khaprail More compelled to fall in huge traffic jam. The passengers of those vehicles were delayed to move their destination as well. A huge chaos was cropped up in this regard. I tried hard to regularize the traffic flow but in vain. However after prolonged talking with the road blockaders, they withdrew the road blockade at around 17.45hrs. Thus the road blockaders assembles unlawfully on NH 31 C in front of Balason Traffic Guard under P.S – Matigara, Dist – Darjeeling obstructed in public way as well as the free flow of the traffic management system without taking any order from competent Authority.

Under the above circumstances, I pray before your esteem that a specific case under proper section of law may kindly be started against above noted (i) Bapi Mandal s/o Nikhil Mandal (ii) Subrata Biswas (iii) Robi Roy (iv) Debn Das (v) Babu (vi) Amit Bala (VII) Pralad Biswas (VIII) Mina Mandal (ix) Chumki Sarkar (x) Bapi Das (xi) Kajal Sarkar and others 60/70 for assembling unlawfully at NH 31 C road in front of Balason Traffic Guard under P.S – Matigara, Dist – Darjeeling. and obstructing in public way without taking any order from competent Authority and arrange for its investigation.
