Subject- Under named Accused Person Showing holy bond of marriage, continuously intercoursed with me.

Sir

I, Smt. Koyel Kar, daughter of late Krishna Kar, resident of Eastern Bypass, Ashigar More, near Apollo Pharmacy, police station - Ashighar under Bhaktinagar, Jalpaiguri, inform you to the effect that the accused person showing holy bond of marriage at Mahananda Kali Temple on 5th May 2024 with false promise and collect consent intentionally and illegally to intercourse with me and tried to grab my property. After marriage, the accused took me to his flat situated at Merryview Residency, Drasharath Pally, Prakash Nagar, Bhanu Nagar, Siliguri, where I came to know that the accused had never obtained a legal divorce from his first wife. Further, I also discovered that he has another wife namely Pampa Kundu Sikdar, with whom he is maintaining a matrimonial relationship and has a child as well. Actually the accused person kept me and continuously intercoursed with me against my will at his flat. Thus, the accused deliberately concealed material facts, cheated me, and committed bigamy. On 6.11.2025 at about 9 PM, the accused person assaulted me physically at Bhanu Nagar's flat and I also stated that the accused person regularly intercoursed with false promise to marry me.

I went to Kolkata after the above incidents and pressured and blackmailed me as if I would not lodge a complaint against the accused person and for this reason the delay in lodging the FIR.

You are requested to enquire about the matter and punish the accused person as per law.
