Subject: Complaint regarding fake Instagram account, identity theft, publication of obscene and defamatory content, and damage to reputation

I, Sidhart Bhattacharya, son of Late Chandidas Bhattacharya; resident of Shivmandir, Bairatal, Vivekananda Road, Halermatha, P.S. Matigara, District- Darjeeling, West-Bengal, Pin- 734013, most respectfully beg to state as follows:

1. That on **14.01.2026**, while I was chatting with my friend namely Chittaranjan Roy through WhatsApp, I came to know that a fake Instagram account was operating in the name of @sidmechu, using my photograph, by some unknown person. The said fake account and post links are as follows:

- 2 That through the said fake Instagram account, private photographs were published, including a kissing photograph with a girl, along with sexually explicit content and malicious, false and defamatory statements. These posts were uploaded around **August-September 2025**, with the deliberate intention to defame, humiliate, and mentally harass me. These posts and images are enclosed herein below.
- 3 That the accused person also tagged these defamatory posts to my former school's official social media page, namely Champion International School, and other popular local social media pages, such as:

- 4 That by such illegal acts, the accused successfully provoked the public against me, projected me in a loathsome and disgraceful manner, and even conducted an Instagram poll portraying me as a villain in society.
- 5 That the accused knowingly published false content with the intention to cause annoyance, insult, injury, criminal intimidation, enmity, hatred and ill will, by misuse of electronic communication, having full knowledge that such false imputations would seriously harm my reputation.
- 6 That due to the intentional and malicious acts of the accused, I have suffered immense mental agony, public humiliation, loss of goodwill, and serious damage to my reputation and social standing. In view of the above facts, I most humbly pray that you be pleased to register a case, investigate the matter, and take strict legal action against the unknown accused person in accordance with law.

I shall remain ever obliged for your kind cooperation.
