Sir,

I, SI Dipankar Roy (30 years), S/o-Lt Nalini Roy, posted at Cyber Crime PS, Siliguri Police Commissionerate, hereby lodge a written complaint stating that today, on 06.02.2026 at approximately 10.00hrs, while engaged in social media monitoring duty at Cyber Crime PS, Siliguri, I came across a Facebook user named Puja Mahato (Profile Link ; <https://www.facebook.com/puja.mahato.245929>). She had posted communally and provocative video which have gone viral with about 4.1k views. The link to the reel video is '<https://www.facebook.com/reel/1748532826552221>'

The circulation of such inflammatory content on social media amount to abetment of communal violence and has the potential to incite unrest among communities within the jurisdiction of siliguri and its surrounding areas

The user, Puja Mahato, daughter of Late Jamin Mahato, residing at Tulsi Nagar, Kholaibaktari, PS Matigara, has previously uploaded similar provocative content. A case Was registered against her under Cyber Crime Ps Case no- 03/26, Dt -21/01/2026, under Section 196(1a)/196(1b)/353(2)/299 of the Bharatiya Nyaya Sanhita (BNS).


Her continued posting of communal and provocative video comments may expose her to retaliatory action, which could cause serious communal tension between two religious groups in her locality. An incident of communal violence had already taken place at Kholaibhaktari and Tulsi Nagar on 18.01.2025, and timely police intervention, along with the introduction of a police picket was implemented as a preventive measure to avert a breach of peace. Accordingly, a specific case has been lodge at Matigara PS vide Matigara PS Case no. 36/26 Dt-19.01.2026 U/S-132/121(1)(2)/3(5)/189(2) BNS.

Under the above circumstance, I request that an FIR be registered against the Facebook user, Puja Mahato, daughter of Jamin Mahato, residing at Tulshi Nagar, Kholaibaktari, PS Matigara, under the appropriate section of law
