

serious assault committed against me today
date 09/02/2026 at 6:40 PM at Birga murder
ground Champasasi

This person assaulted me with the intention
to kill, causing a serious injury to my head.
I was immediately take to Siliguri District
hospital, where doctors treated me and
applied 4 stitches to my head.

at the time of the incident, I was carrying approximately Rs: 7000 in cash, which the accused took and fled from the spot after assaulting me.

I received medical treatment today at Siliguri District hospital. I have the medical report, hospital slip, and photographs of my injuries copies of which I am attaching with this application.

Therefore, I humbly request you to kindly register an F.I.R against the accused under appropriate section of law and take immediate legal action so that I may receive justice.
