Subject: Complaint against the below mentioned accused persons.

Respected Sir/Madam,

I, BIVHA GUPTA wife of Sitaram Gupta resident of tea auction road, Pokhai jote, P.S. Pradhan Nagar, P.O. Champasari, District- Darjeeling, 734003 respectfully submit this complaint against the following persons: **1. Abhijit Gupta, 2. Prem Gupta, 3. Ritu Gupta, 4. Poonam Gupta, 5. Chitranjan Gupta**, All residents of tea auction road, Pokhai jote, P.S. Pradhan Nagar, P.O. Champasari, District- Darjeeling, 734003.

Sir/Madam, the dispute arose in connection with our property matter. The above-named persons threatened us that they would file a legal case against our property in order to harass and pressurize us. When we requested them to consider our genuine situation and resolve the matter amicably, they illegally demanded a sum of ₹6,00,000 (Rupees Six Lakh Only) from us.

They clearly stated that if we failed to pay the said amount, they would cause serious harm to us and our family members and would initiate legal proceedings to trouble and mentally harass us. When we refused to pay such a hefty and unlawful amount, they carried out their threat and filed a case against us in the Hon'ble High Court with malicious intention to harass and extort money from us.

the accused persons verbally abused me and my family members using filthy and threatening language and also physically assaulted and intimidated us. Their actions have caused us severe mental trauma, fear, and insecurity.

On one occasion, dated 09/02/2026 at night the accused persons namely Chitranjan Gupta and Abhijit Gupta came near our residence in a drunken state, created nuisance in front of our house, and started shouting outside our main gate aggressively. They shouted threats and attempted to intimidate us, causing

fear and panic in our family. Their conduct was disorderly, unlawful, and posed a serious threat to our safety.

Their continuous actions have caused us severe mental trauma, fear, and insecurity.

It is also submitted that we have already filed an application/complaint against the persons before the Commissioner, SMC, dated 22/09/2025, regarding their illegal acts and threats.

Importantly, I have audio recordings on my mobile phone containing the threats and the illegal demand of ₹6,00,000 made by the persons. I am ready and willing to submit the said recordings and any other supporting evidence to assist in the investigation.

I therefore request you to kindly register an FIR against the above-named persons and take strict legal action against them as per law. I also request immediate protection for myself and my family members, as we apprehend further danger from them.
