Langra @ Bbausa Son of Hira singh and 2 others, Further I State that on dated-8/02/2026 around 8:00 Pm Near Ganga nagar River Ghat I was going to join marriage ceremony at that time the all accused persons stop me and started demanded money from me at that time they were in intoxicated situation and keep some iron rod and wooden stick in their hand, they grab my collar and take my money around Rs.2250/- from my pocket as well as they snatched my gold neck chain and started beaten me, they broke a bottle(Glass) and keep on my neck and threatened me if I disclosed or filed any police complaint then they kill me, but I pray them and ran away from the place. today on dated 10/02/2026 I got pain upon my body by their injury and suddenly they saw me and stop me around 12:30 Pm near my house and slapped me and again threatened me they again take money from me around Rs.500/- from my pocket there after .I go to hospital for medical treatment and due to scared I did not go to filed my complaint before you but today they again assaulted me and extorted money from me.
