Darjeeling beg to state that my daughter namely Meghna Dutta Age-23 years, is missing from 05/02/2026 around 10.30 P.M. while she has gone to take some grocery item from nearby shop. we have been searching her since then with all of her friends and relatives but we don't have any trace her, finally I have submitted a missing diary to you on 07/02/2026.

Today while I along with my all relatives were searching the whereabouts of my daughter everywhere, I came to learn that one person namely Sushant Saha, S/o. Malin Chandra Saha, Haiderpara, Shiv Ram Palli, Sarat Chandra Palli, Samity Road, Ward No. 40, P.S. Bhaktinagar, District Jalpaiguri along with his friend namely Barun Das have forcibly taken away my daughter somewhere else and they have confined/concealed my daughter for their illegal intention. I would like to mention that my daughter was wearing different Gold ornaments, when she was abducted by the above named miscreants.

Therefore, I request you to take necessary legal action against said namely 1) Sushant Saha, S/o. Malin Chandra Saha, Haiderpara, Shiv Ram Palli, Sarat Chandra Palli, Samity Road, Ward No. 40, P.S. Bhaktinagar, District Jalpaiguri(M-7074635359 & 6296059593) and 2) Barun Das (M-8617592001), for punishing them as per provision of law. And for this kindness, I shall much oblige to you.
