I USHA RAY, W/O - Bisay Shankar Roy, r/o - Hame-Krishna
Pally, P.O & P.S - Bagdogra wants to inform you of a serious brutal
assault on my said husband, Bisay Shankar Roy on 7th Feb, 2026, near
about 1:30 pm at near ICP Model Army camp.

That, my said husband was brutally assaulted to death
by a person namely Md Subhan, and his mobile number is 86375-
85730. That, dt- 7th Feb 2026, my husband visited the said
person in a business matter of scrapping, as my husband is involved
in scrapping business. That my husband on that day informed me
that he is going to visit the said person for payment
related matter in the scrapping business. Later, that day my
husband returned home by 3:30 pm, where he was injured
in head as he said. He was assaulted by the said person
Md Subhan and his helmet broke. That, after that day 8th Feb
2026, that my said husband had a severe pain in his head.
After that 9th Feb 2026 my husband had a very bad pain
and injury in his head, due to which, he is to admitted
in Neotia Hospital. After that hospital authority informed
that the condition was admitting in Hospital is that Head
injury.

After that my said husband is in ventilation and is in
a deep agony.

That, Sir this is a serious offence and also a threat to life to my said husband, kindly take strict action to the provision of law as my husband is suffering a death situation due to the said assault and do the needful.
