(M/20), s/o- Late Ramsagarat Ray, resident of Singhijhora, PS- Bagdogra, Dist- Darjeeling (Ph. No. 8207274702). On search, a huge quantity of foreign cigarettes got recovered from the truck. Then I started counting. On counting, total 6500 packets WIN King Size Cigarettes, each packet contains 20 cigarettes i.e. total 1,30,000 pcs. Cigarettes and total 2650 packets ESSE Special Gold Super Slim American Blend, Korea Cigarettes, each packet contains 20 cigarettes i.e. total 53,000 pcs. Cigarettes got recovered. On demand, they could not provide any valid document or purchase in respect of the recovered cigarettes. Besides, one realme NARZO 70X 5G android mobile phone having IMEI No. 862859073876159 of accused Main Uddin, one realme android mobile phone (model No. RMX3990) having IMEI No. 863268070870737 of accused Samir Ali, Cash Rs. 1000/- in the denomination of Rs. 500/- x 2 notes from the possession of accused Samir Ali and Driving License of accused Chumir Ali having D/L No. AS14 20190006567 got recovered. On further interrogation, the driver disclosed that they had procured those foreign cigarettes without valid document from Assam and Imphal and had been proceeding to Bihar for its clandestine disposal for their wrongful gain. The driver Chumir Ali @ Samir Ali is the king pin of this crime. Thus their involvement is clearly transpired in this case. Accordingly, I seized the recovered articles including the Eicher DCM six wheeler Truck red in colour displaying No. AS-28AC-0323 along with its ignition key from their joint possession under proper seizure list in presence of the independent witnesses. At last, I arrested them after communicating them the ground of arrest in writing to prevent the accused persons from committing any further offence, to prevent them to cause disappearance of evidence as well as for proper investigation of the case and issued memo of arrest in this regard. The process of search, seizure & arrest is done in between 14:18 hrs & 15:10 hrs on 09.02.2026. The entire process of search, seizure & arrest is done through audio-video electronic means using Govt. mobile App 'WB E- Sakshya vides Evidence Certificate No. C-421-51098-20260209160229.

Under the above fact & circumstances, I request you to initiate a specific case under proper sections of law against the above mentioned two involved arrested accused persons named Chumir Ali @ Samir Ali (M/34), s/o- Late Bacher Ali, resident of Satmukhi Gaon, PO- Balajan, PS- Baghbar, Dist- Barpeta, Assam- 781308 (Aadhaar No. 8188 1855 5260) & Main Uddin (M/21), s/o- Matiyar Rahaman, resident of Lehi, Nirala N.C, PO- Nirala, PS- Kashumara, Dist- Barpeta, Assam- 781308 (Aadhaar No. 6524 9659 2592) and arrange for its investigation.
