Sir,

I, ASI Harikishore Roy of Bagdogra PS, SPC on duty officer of Bagdogra PS do hereby lodge this written complaint against i) Biswajit Sen (28) S/O- Ranjit Sen of Pramodnagar, PS-Bagdogra, Dist-Darjeeling ii) Dinesh Rajak (25) S/O-Banarashi Rajak of Khudirampally, PS-Bagdogra, Dist-Darjeeling to the effect that on 09.02.2026 while performing scheduled table duty at about 22.15 hrs ASI Shekhar Lama of Bagdogra PS, SPC along with force who were performing K-35 van duty brought two persons namely i) Biswajit Sen (28) S/O- Ranjit Sen of Pramodnagar, PS-Bagdogra, Dist-Darjeeling ii) Dinesh Rajak (25) S/O- Banarashi Rajak of Khudirampally, PS-Bagdogra, Dist-Darjeeling under arrest U/S 292 BNS. After completion of all hazat rules while I am requested ASI Shekhar Lama to put them into PS lock up at that time they started to misbehave with us. I tried to control them many times but all in vain. Suddenly they become very furious and started to use filthy languages upon me and also assaulted me with fist and foot, to discharge my Government duty and also vandalised the various documents as well as damaged the property and threatened me in dire consequences. Also while sentry LC 1356 Ramana Fanning with the help of other forces of Bagdogra PS, SPC trying to put them into PS lock up then the above noted arrested persons pushed her and used slang languages upon her. As a result we managed to put them into PS lock up.


Under the above fact and circumstances, I request you to initiated a specific case under proper section of law against the above mentioned two persons namely i) Biswajit Sen (28) S/O- Ranjit Sen of Pramodnagar, PS-Bagdogra, Dist-Darjeeling ii) Dinesh Rajak (25) S/O-Banarashi Rajak of Khudirampally, PS-Bagdogra, Dist-Darjeeling and arrange for its investigation.
