Sub: Complaint against molestation and outrage of my modest by Sanjit Paul and his family members.

Sir,

I Sujata Das , aged about 28 years, D/o Ranjan Das, R/O – 24/2/25 Bibadi Sarani , Haidarpara, Siliguri (M. Corp), Dist: Jalpaiguri, West Bengal 734006, beg to state as follows

That today on 12.02.2026 at around 5 p.m myself and both my parents Smt. Lakshi Sutradhar and Sri Ranjan Das visited my grandfather Sri Kalachand Sutradhar, aged about 77 years old, S/o Late Bhashan Sutradhar, R/O- 11, Pritilata sarani, Haidarpara, Ward No- 39, Siliguri (m. corp), Dist: Jalpaiguri, West Bengal 734006. At that moment and place the occupant of the second floor of that house Sanjit Paul and his wife raised a fight with my parents and attempted to physically assault my parents. In protection I tried to save my parents from their clutch as they were being attacked severely by Sanjit and his wife.

At the very moment Sanjit Paul hit me indecently and molested me. He tried to disrobe me and outrage my modesty. I was in a miserable condition and both my parents were also confined by them and could not come to my protection.

Sanjit Paul and his wife threatened me and my parents that if we ever try to enter to the house of my Grandfather we have to face dire consequence for that.

I am traumatised at the savageness of Sanjit Paul and his wife. On an earlier instant in November 2025, in a similar situation my mother had filed a complaint with Bhaktinagar police station against that Sanjit Paul as he had assaulted my mother.

Sir my request to you to lodge an FIR against Sanjit Paul and his wife for outraging my modesty, committing physical assault on my mother and father and take strong legal action against them to protect us. We apprehend that they will try to lodge false police complaint in order to harass us.

I am attaching herewith medical examination documents issued by Siliguri District Hospital at 5.45p.m on 12.02.2015(on the same day).
