Sir,

It is to inform you that I, **Debraj Das**, S/O- Kartik Ch Das , DE & SM, Pradhannagar CCC; being empowered by the Electricity Act 2003, do hereby lodge a complaint against **BISWAJIT SAHA(USER)**, S/O- **LT SUJIT KR SAHA**, Address- 2/7 Baghajatin Colony , W No. 02, Dist-Darjeeling, Pin-734003 for **reconnecting a deemed disconnected meter illegally and unauthorizedly**.

Today i.e, on **12.02.2026**(15.55 hrs), I came to 2/7 Baghajatin Colony , W No. 02, **P.S - Pradhannagar**, Dist-Darjeeling; in my officially hired vehicle for a routine inspection. I was accompanied by (i) Bhaben Roy SO(S&LP) Darjeeling Region, (ii) Bijay Lakhra, SE(E), S&LP, Darjeeling Region, (iii) Rabi Sankar Singh, Sr OE, Pradhannagar CCC & other technical staffs of Pradhannagar CCC.

On inspection of the premises ,after observing all formalities, I found that the meter **G120245** (Consumer Name- **BISWAJIT SAHA(USER)**, **Domestic Urban** Category, Con Id-**412016545**, Date of disconnection- **15.01.2024**, Status-Deemed) has been reconnected illegally and unauthorizedly and is being used for domestic purpose.

The meter **G120245** has an **outstanding due of Rs.12337.93/-** and **LPSC-Rs.3920.55/-** (as on 12.02.2026) I disconnected the connection of **BISWAJIT SAHA(USER)** & seized the meter **G120245**, after preparing the seizure list duly signed by the witnesses. Local people were present but none appeared.

Seized Articles:

- i. 1 phase energy meter **G120245**, 240V, 5-30A , Make- GENUS(L/R-51728 KWH)

BISWAJIT SAHA(USER) was present at the premises & received the Notice, Inspection Sheet & Seizure list. As such, **BISWAJIT SAHA(USER)**, has reconnected a deemed disconnected meter illegally and unauthorizedly and using it for domestic purpose and is liable for prosecution U/S **138 1(b) & 135 1(e)** of Electricity Act 2003. Hence, you are requested to treat this as FIR.
