I, Mrs. Susmita Chakraborty, wife of Sujit Choudhury, matrimonial house at Rajiv Nagar, Municipal Corporation, Post Office- Pradhan Nagar, Police Station- Pradhan Nagar, District- Darjeeling, in the State of West Bengal, PIN-73403 and presently residing at Battala, Samar Nagar, Post Office- Champasari, Police Station- Pradhan Nagar, District- Darjeeling, in the state of West Bengal, PIN- 734 003, would like to inform as follows:

1. I am presently residing at the present address as mention above with my daughter after being driven away by my husband Sujit Choudhury and his brothers Deep Chand Choudhury and Pradip Choudhury and his mother Manju Choudhury and father Laxmi Choudhury.
2. I got married with Sujit Choudhary on 15/05/2018, and out of the wedlock a daughter was born on 19/11/2019.
3. That right after my marriage with Sujit Choudhury, I was subjected to immense mental and physical torture by my husband Sujit Choudhury and his brothers Deep Chand Choudhury and Pradip Choudhury and his mother Manju Choudhury and father Laxmi Choudhury. My mother-in-law Smt. Manju Choudhury used to intentionally starve me on regular occasion. There were many days when I had to be hungry the entire day and also sleep with an empty stomach. If I ever try to raise any objection or ask for food, then at the behest of Smt. Manju Choudhury, her 3 sons Sujit Choudhury, Deep Chand Choudhury and Pradip Choudhury would beat me with slaps, punches, kicks and sometimes with objects like broom, kitchen utensils, belts.
4. In the year 2021 when I was beaten very badly in particular by Sujit Choudhury and Pradip Choudhury, I was forced to leave my matrimonial house and I had to come to my present residence. Few days thereafter Sujit Choudhury came in front of my present
