Subject: - F.I.R.

Sir,

With due respect, I am producing herewith one (01) accused person namely Md. Hanif (59 yrs) S/O Lt. Md. Azahar of Adarsha Nagar, W/No. 04, P.S.- Siliguri, Dist. Darjeeling under arrest and the following articles under proper seizure list viz :- 1) One red and blue colour bag containing (i) 30 (thirty) bottles of Old Monk Premium XXX RUM, each bottle containing 180 ml i.e total (30 x 180 ml) = 5.4 ltrs and (ii) 07 (seven) bottles of "COSMOS FIFTY" Deluxe whisky each bottle containing 750 ml i.e. total (07 X 750 ml.) = 5.250 ltrs - Marked as Exhibit "A". Out of which 01 (one) bottle of Old Monk Premium XXX RUM containing 180 ml taken as sample from Exhibit "A" for examination and marked as Exhibit "A1" and 01 (one) bottle of COSMOS FIFTY" Deluxe whisky containing 750 ml taken as sample from Exhibit "A" for examination and marked as Exhibit "A2". I ASI Prabal Sarkar of Pradhan Nagar PS, SPC do hereby lodged this written complaint against the above mentioned arrested accused person namely Md. Hanif (59 yrs) S/O Lt. Md. Azahar of Adarsha Nagar, W/No. 04, P.S.- Siliguri, Dist. Darjeeling to the effect that on 13.02.2026 at about 23.35 hrs I received specific secret information that one person carrying and possessing a huge quantity of illicit liquor without any documents was standing at Opposite SJDA Building, Siliguri Junction under P.S. Pradhan Nagar and waiting there to deliver the same to his design customers for his wrongful gain.

Accordingly, I diarized the matter in PS General Diary of Pradhan Nagar P.S. vide GDE No. 843 dated 13.02.2026, and the matter was intimated to you. As per your kind order and direction, I along with force proceeded to the spot by government vehicle with investigation kit to verify the veracity of the information.

At about 23.55 hrs we reached at Siliguri Junction and contacted with my source. Being pointed by the source we noticed that one person was standing with a bag in his possession at opposite SJDA Building, Siliguri Junction. Accordingly, we cordoned the place from every corner and managed to detain the said suspect with a red and blue colour bag in his possession. Then we disclosed our identity as police personnel. On interrogation he disclosed his identity as noted above and on further interrogation he admitted his guilt and disclosed that he is carrying illegal illicit liquor in his bag and waiting there to deliver the same to his design customer for his wrongful gain. On search the bag in his possession, I recovered the above mentioned articles from the possession of the said detainee person. On demand the said detainee person failed to produce any valid licence or documents in respect of above mentioned illicit liquor recovered from his possession. Accordingly, I seized above noted articles under proper seizure list in presence of independent witnesses. The entire process of search and seizure was made in between 01.19 hrs to 01.35 hrs on 14.02.26 under the coverage of videography executed by Somnath Chatterjee, S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No 22, PS- Siliguri, Dist. Darjeeling as per the norms of BNSS and subsequently I arrested the said detainee person namely Md. Hanif (59 yrs) S/O Lt. Md. Azahar of Adarsha Nagar, W/No. 04, P.S.- Siliguri, Dist. Darjeeling under proper memo of arrest and observing all the formalities for violating the norms of Bengal Excise Act and brought to Pradhan Nagar PS for further investigation.

Therefore, I pray before your good self that a specific case may kindly be initiated against the arrested accused person namely Md. Hanif (59 yrs) S/O Lt. Md. Azahar of Adarsha Nagar, W/No. 04, P.S.- Siliguri, Dist. Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
