Subject: FIR regarding physical assault, criminal intimidation and continued harassment of my father

Respected Sir/Madam,

I, **Uday Saha, S/o Ujjal Saha**, resident of Naukaghat Main Road, Near Mani Bakery, Ward No. 31, P.O. Siliguri Bazar, P.S. New Jalpaiguri, Siliguri, Dist. Darjeeling, do hereby lodge this First Information Report against one **Shankar Mahato @ Kalia, S/o Sukhdev Mahato**, working as a labourer at Jalpai More Mill, near Ranibala Hotel.

That my father, **Ujjal Saha**, aged about 52 years, is a businessman dealing in logs and wood at Jalpai More Mill, Siliguri, beside Ranibala Hotel. The said accused is a known rowdy and aggressive individual. He has a prior criminal record and had previously attacked a security guard at the same mill premises, for which he was arrested and had undergone imprisonment. His conduct has consistently been violent and unlawful.

For the past several months, the accused has been harassing and threatening my father without any justifiable reason. He has been creating fear and obstruction in his lawful business activities. His repeated acts of aggression have caused mental trauma and serious apprehension for the safety of my father and our family.

That today, i.e. on 13.02.2026 at about 8:45 - 9:00 AM, while my father was present at Jalpai More Mill in connection with his regular business activities relating to logs and timber, the accused person, namely Shankar Mahato @ Kalia, S/O Sukhdev Mahato without any provocation, wrongfully restrained him and physically assaulted him. He attacked my father with intent to cause injury and criminally intimidated him with dire consequences.

That thereafter, I took my father to North Bengal Medical College and Hospital, Siliguri to tend to his wounds. I am attaching the medical report along with this FIR. The incident was witnessed by several witnesses, many of whom are working at the mill and took place within the jurisdiction of your police station.

That my father has been grievously hurt in his face especially in his midface and lacerations in lower lips and mouth. The acts of the accused constitute

offences punishable under relevant provisions of the Indian Penal Code, including but not limited to Sections 323, 325, 341, 506, and other applicable sections.

I therefore request you to kindly register this FIR, conduct a thorough investigation, take immediate legal action against the accused person, and ensure the safety and protection of my father and our family.

I am ready to cooperate with the investigation and provide any further details as required.
