Dear Sir,

With due respect I Smt. Poonam Sahani, Wife of Prasant Kumar, resident of Rabindra Neer Building, 3rd Floor, Aurobinda Pally, P.S Siliguri, Dist. Darjeeling, would like to inform you that, I lodge this written complaint against one Nilanshu Mandal for continuously harassing, threatening and misbehaving with me.

I would like to further inform you that my younger sister namely Mamta Sahani was married with one Nilanshu Mandal about 7 years ago through a love marriage. However, for the last two years, said Nilanshu Mandal has abandoned my sister, and she is presently staying with my mother in Delhi.

For the past few days, said Nilanshu Mandal has been making indecent proposals to me and demand me to have physical relations with him. He often misbehaves with me in public places, catches hold of my hands, and claims that he has some "right" over me.

On 04th February, 2026, at around 7:00 PM, when I was going from my shop towards my flat, back side of Siliguri Boys School and Tathya Kendra, said Nilanshu Mandal suddenly followed me on his scooty, stopped my vehicle forcefully, caught hold of my clothes, and started pulling and assaulting me and tried to force me to go with him.

He threatened me saying that he will compulsorily establish a physical relationship with me. When I resisted, he further threatened that if I do not agree

to his proposal, he will falsely implicate me and my family members in criminal cases

Sir/Madam, I am extremely frightened and mentally disturbed due to his continuous harassment and threats. His acts amount to serious offences under the law.

Therefore, I request you to kindly take immediate legal action against the Nilanshu Mandal under appropriate sections of law and provide me necessary protection.
