he forcefully entered into our situated at dama house  
Pradhan Nagar and destroyed all house hold articles  
and attacked upon me and my two daughter with  
iron rod. When we protested that alleged person started  
abusing and threatened with dire consequence. His  
intention to kill me and my daughters. Due to this I  
and my both daughter sustained injured and treated  
at Siliguri District Hospital.

Hence I pray before you may kindly  
consider my requisition and take necessary action  
against him and obliged.
