nightly with an intention to molest me and seeing the said situation, when my husband tried to rescue me from their clutches, my brother-in-law and his wife also assaulted my husband mercilessly and considering the said situation, when we started hue and cry, some adjacent and neighboring peoples came there but they did not listen their request and in presence of the neighboring peoples, they have also assaulted me and my husband and also threatened with dire consequences.

Sir, due to the aforesaid assault, I along with my husband have sustained severe injury on our person and thereafter, I treated at Siliguri District Hospital and still now, they are threatening us with dire consequences and due to such type of torture, we are passing our days in mental trauma and anxiety and we apprehend that they may come again in our room with an intention to destroy our life and property. Sir, as we are in a mental trauma, some delay has been caused for lodging this complaint.

I, therefore, request you to kindly investigate into the matter properly after treating my present complaint as an FIR and please take appropriate legal action against my brother-in-law and his wife as per the provision of law and oblige thereby.



With due regards, I, **SMT. RUMPI SARKAR**, Wife of Sri Biswajit Sarkar, Resident of 114, Bankim Chandra Road, East Vivekananda Pally, Ward No. 38 of S.M.C., Siliguri, P.O. Rabindra Sarani, P.S. Bhaktinagar, Dist. Jalpaiguri, Pin: 734006, would like to lodge this Written Complaint before your authority to the effect that I am the legally married wife of Sri Biswajit Sarkar and after marriage, I along with my husband have been residing in the aforesaid address in the first floor of a two storied building.

Sir, my Brother-In-Law namely Sri Surojit Sarkar and his wife namely Smt. Sujata Chowdhury (Sarkar) are also residing in the same building in the Ground Floor.

Sir on 11/02/2026 at about 04.30 P.M., while I was cleaning the staircase area of our building in usual course, my Brother-In-Law namely Sri Surojit Sarkar <sup>wife</sup> has started quarrel with me intentionally on the ground that due to my cleaning, some dusts have been caught in his shoes and started to abuse me with filthy and offensive languages and also threatened me with dire consequences and inspite of his such type of ill-behavior, I went back to my room quietly as I do not wants to argue with him.

After sometime, I went to the rooftop of the said building in order to take my cloths back and at that time also, my brother-in-law as well as his wife started to abuse me with filthy and abusive languages and also threatened me by saying that they will ruin our life and property permanently and nobody will do anything against them and even after receiving such type of ill-behavior and threatening from my brother-in-law and his wife, I did not make any protest considering our brotherhood relationship.

Thereafter suddenly at about 10.30 P.M., while I along with my husband were taking our dinner, my brother-in-law and his wife came in front of our room in the first floor in a drunken state and knocked our door repeatedly and after opening our door, my brother-in-law forcefully entered into room and pushed me forcibly and he along with his wife started to assault me with fist and blows and also torn my
