Sir,

In producing herewith one arrested accused person namely Bharat Das (M/38yrs) S/O- Lt. Mantu Das of 17, B.T. Road, Baranagar(m), Baranagar City More, Kalicharan Ghosh road, W/No-23, Kol-50, PS- Baranagar, Dist. North-24 Parganas (not verified) along with the following articles under seizure as per seizure list:

- i) One Pink coloured Trolley Bag styled as Sinomate, containing two black coloured plastic carry bag marked as Exhibit-A and Exhibit -B. Exhibit-A containing 5 (five) KG Ganja and Exhibit -B containing 7.5 (seven Kg and five hundred grams) KG Ganja.
- ii) One Blue coloured Trolley Bag, containing two black coloured plastic carry bag marked as Exhibit-C and Exhibit -D. Exhibit-C containing 5 (five) KG Ganja and Exhibit -D containing 4.3 (Four Kg and three hundred grams) KG Ganja.
- iii) One black coloured Samsung Galaxy A03 Core mobile phone bearing IMEI No. 350655753830873 and 356710803830870
- v) One Blue Colour keypad mobile phone styled as "JIOBharat" bearing IMEI No 357143110389530.

I, SI Ganesh Roy of Detective Department, Siliguri Police Commissionerate do hereby lodge this written complaint against above noted person to the effect that on 14/02/2026 at 17:45 hrs I received a specific source input that one person was standing at Mohun Bagan Sarani near Airview more under PS Siliguri with two trolley bag containing huge quantity of Ganja carry the same to Kolkata for sell for his wrongful gain. The matter was diarized in DD, SPC, GDE No.76, Dt- 14.02.2026 and informed the matter to the ACP, DD, SPC in written and being directed, I along with SI Biswajit Ghosh, ASI Sushanta Dey, C/ 686 Arup Saha and C/670 Ratan Roy all of DD, SPC left for Mohun Bagan Sarani near Airview more under PS- Siliguri by Govt. vehicle to verify the veracity of the information vide DD, SPC PS M.C C. NO 40/26 Dt. 14/01/2026.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

At the time of departure from DD, SPC, office I took envelope, white paper, sealing wax, gum, seal, Digital weighing machine (Certified by the weight and Metallurgy department) etc.

After reaching at Mohun Bagan Sarani near Airview more, I contacted two available independent persons namely (i) Md. Amir (30yrs) S/O- Md. Jakir Hossen of Tikiya Para, Matangini Colony, W/no- 28, PS- Siliguri, Dist- Darjeeling(7863934176), (ii) Karan Mahato (25yrs) S/o- Anil Mahato of Tikiya Para, Matangini Colony, W/no- 28, PS- Siliguri, Dist- Darjeeling(8653761222) and make them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed and subsequently being pointed. As shown by my reliable source apprehended above noted person.

Thereafter, we disclosed our identity and the information in hand and stated him that he will be searched in person for the purpose. At this, he after disclosing his identity as noted above admitted that he have illegally possessed ganja in his possession for carrying and selling the same to his designed customers at Kolkata. I then gave him option in writing whether he wanted to be searched in presence of an Executive Magistrate or by any Gazetted Officer. Then he agreed to be searched in presence of any one of the above. I also offered the independent witnesses and the accused person to search our Police Party as per provisions but, they did not search the police party.

Accordingly, I informed the matter to ACP, DD, SPC and as per his kind direction, informed to Sri Sonam Lama, Inspector of police, DD, SPC, regarding the information and requested him to come at Mohun Bagan Sarani, beside Mahananda River, near Surya Sen Park under Siliguri PS to remain present and to supervise the search and seizure. At 19:05 hrs Sri Sonam Lama, Inspector of police, DD, SPC arrived at the spot and in presence of two independent witnesses search has been conducted of the detained person following all formalities keeping his decency and recovered the above noted articles from the conscious possession of accused. On demand, in presence of Sri Sonam Lama, Inspector of police, DD, SPC the detained person namely Bharat Das failed to produce any valid document in support of possessing of the Ganja.

Thereafter, I weighted the recovered bags and packets with the weighing instrument which stand total of 21.800 (twenty one Kg and eight hundred grams) Kg in four plastic carry bag viz - 1) Exhibit-A - 5 Kg, 2) Exhibit-B-7 Kg 500 grams, 3) Exhibit-C-5Kg and 4) Exhibit-D-4Kg.300 grams. Then, I seized the above noted articles at the spot under proper seizure list and also labeled and sealed the articles in presence of Sri Sonam Lama, Inspector of police, DD, SPC and independent witnesses and also obtained signature of the above noted witnesses and Sri Sonam Lama, Inspector of police, DD, SPC and put my signature too and also acknowledged by the accused person. The whole process of seizure was made in between 19.05 hrs to 19.40 hrs under proper videography.

Being further asked the apprehend persons namely Bharat Das admitted in presence of Sri Sonam Lama, Inspector of police, DD, SPC and other witnesses that he and his associates have procured the ganja clandestinely for the purpose of selling the same in high rate to his designed customers at Kolkata for his personal gain by illegal means. He also disclosed that he and his associates are dealing in such business of procuring and selling of ganja illegally for last few years.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused person namely Bharat Das is involved in procuring and selling of Ganja illegally contravening the norms of NDPS Act.

Then, I arrested the above noted accused persons namely Bharat Das after observing all formalities and informing the ground of his arrest and issued necessary Memo of Arrest.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person namely Bharat Das (M/38yrs) S/o- Lt. Mantu Das of 17, B.T. Road, Baranagar(m), Baranagar City More, Kalicharan Ghosh road, W/No-23, Kol-50, PS- Baranagar, Dist. North-24 Parganas (not verified) and others arrange for its investigation.
