Sir,

With due respect I am producing herewith one (01) arrested accused person namely Shibu Mahato (39 yrs. /F) S/O- Dukha Mahato of Porajhar, Near Railgate, PS- NJP, Dist- Jalpaiguri under proper arrest memo and the following articles under seizure. The ground of arrest has duly been communicated with him.

- i) 12 (Twelve) bottles of Himalayan Gold Country Spirit 60 Up containing 600 ml in each bottle in sealed condition marked as Exhibit A.

I SI Tanmoy Kundu presently attached with New Jalpaiguri PS, Siliguri Police Commissionerate under your kind control beg to state that today on 12/02/2026 during special raid duty received secret source information that person namely Shibu Mahato is selling liquor without any valid license for his illegal gain. Accordingly, I diarized the fact in General dairy vide PS GDE No: 547 dated 12/02/2026 and informed the fact to you. As per your kind direction and instruction myself along with ASI Nilam Swarnakar, C/453 Uttam Dey, C/1462 Sajam Tamang, VP 13 Jamirul Islam, VP/08 Laxman Roy left for Porajhar, PS- NJP, Dist- Jalpaiguri to work out the information in hand. We arrived at the Porajhar road Near TMC party office and being identified by the source we apprehended above noted person. On search the above noted liquor recovered from his possession. On demand he failed to produce any documents/license in respect of store/sale the illicit liquor recovered from his possession. On being asked he disclosed his name and identity as Shibu Mahato (39 yrs. /F) S/O- Dukha Mahato of Porajhar, Near Railgate, PS- NJP, Dist- Jalpaiguri and also disclosed that he is selling such liquor since long for his illegal gain. Accordingly, I seized the above noted liquor from his possession under proper seizure list in presence of local witnesses and arrested him under proper memo of arrest after observing all the formalities of arrest. The whole process of search and seizure was made in between 18.55 hrs to 19.05 hrs on 12.02.2026 under proper videography.

Hence, I pray to you considering the offence a specific case may kindly be started against the arrested accused person namely Shibu Mahato (39 yrs. /F) S/O- Dukha Mahato of Porajhar, Near Railgate, PS- NJP, Dist- Jalpaiguri under proper section of law and arrange for its investigation. Seized articles were handed over the Makhana Officer with proper seizure list after maintaining all formalities.
