Sub: - Letter of Complaint against one Tabibor rahaman (42), s/o- Late Muslimuddin
of Shantipara, P.O-Bhaktinagar, P.S- NJP , Dist. Jalpaiguri for illegal storing of
Domestic Gas Cylinder and Commercial gas cylinder at his own house .

Sir,

In producing herewith the following seized articles with original seizure list, viz:-

- 1) 08 Pieces of Indane Domestic Gas Cylinders fully empty,
- 2) 01 Pieces of HP Commercial Gas Cylinders fully empty.

I SI Raju Sarkar of Enforcement Branch, Siliguri Police Commissionerate do hereby lodge the written complaint against accused person namely Tabibor Rahaman (42), S/O - Late Muslimuddin of Shantipara, P.O-Bhaktinagar, P.S- NJP , Dist. Jalpaiguri to the effect that on 14/02/2026 at about 11:00 hrs received a secret source information that one Tabibor Rahaman (42), s/o- Late Muslimuddin of Shantipara, P.O-Bhaktinagar, P.S- NJP , Dist. Jalpaiguri is illegally storing and selling Domestic LPG and Commercial cylinders i.e. Indane and HP at his house for the purpose of selling in open market without any valid license or documents for his wrongful gain. Hence I diarized the matter vide EB, SPC GDE No. 82 Dt. 14/02/2026 and informed the matter to ACP EB, SPC and as per his instruction myself along with ASI Arghya Das, ASI Chandi Roy, L/C 1270 Deeptina Gazmer, C/1832 Nawab SK all of EB, SPC left EB Office to proceed Shantipara, P.O-Bhaktinagar, P.S- NJP , Dist. Jalpaiguri to execute the information. This refers EB, SPC GDE No. 83 Dt. 14.02.26 and C.C. No. 21/25 Dt. 14.02.26.

At about 13:30 hrs we reached at Shantipara, P.O-Bhaktinagar, P.S- NJP , Dist. Jalpaiguri and contacted with source and being shown and identified by him, I along with officers and force conducted raid in the house of Tabibor Rahaman of Shantipara, P.O-Bhaktinagar, P.S- NJP , Dist. Jalpaiguri and found that the above noted accused person is storing and selling loaded LPG and Commercial cylinders i.e. Indane & HP. On searching, the above noted seized articles have been recovered from his house. On being asked the above noted accused person failed to produce any valid documents in support of above noted seized articles.

It is crystal clear that the said person namely Tabibor Rahaman (42), s/o- Late Muslimuddin of Shantipara, P.O-Bhaktinagar, P.S- NJP , Dist. Jalpaiguri is storing and selling the Domestic and Commercial gas cylinders at his rented house for his wrongful gain. As per local enquiry it came to light that the above noted person storing and selling gas negligently with respect to fire or combustible matter, which may endanger human life or likely to cause hurt or injury to person at that locality area. Tabibor Rahaman does not have any valid License/ Permit of dealing /distribution / selling and storing LPG. Thus the above noted accused person

violated the provision of West Bengal Cooking Gas (License and Control) order 1985 and other Government Orders.

Accordingly I seized the above noted seized articles as per seizure list in presence of local witnesses namely 1) Md. Nasirul Islam S/O Lt Mosiruddin Shantipara, P.O-Bhaktinagar, P.S- NJP , Dist. Jalpaiguri and 2) Noor Banu W/O Anisur Rahaman, Shantipara, P.O-Bhaktinagar, P.S- NJP , Dist. Jalpaiguri. The seizure was made in between 13:45 hrs to 14:15 hrs.

Hence, I pray that a specific case may be recorded against the accused person namely Tabibor Rahaman (42), S/O - Late Muslimuddin of Shantipara, P.O-Bhaktinagar, P.S- NJP , Dist. Jalpaiguri U/S 287/3(5) BNS R/W Sec 7(1)(a)(b)(c) of EC Act 1955 and other appropriate sections of law.
