Sir,

With due respect, I am producing herewith 01 (One) arrested accused person namely Siusan Oraon (22 Years Approx), S/o- Banna Oraon of Putinbari, PO-New Chumta, PS- Matigara, Dist- Darjeeling and the following articles under seizure :-

1. One Mahindra Tractor with trolley having displayed No- WB 92 H 8889 loaded with river bed materials (Sand).

I, Dipak Kr. Chhetri, presently attached with Matigara PS under your kind control, beg to state that on 14.02.2026, during my evening mobile van duty, vide Matigara PS GDE No. 821, Dated- 14.02.2026, when myself along with force namely C/219 Sanatan Chitrakar, C/523 Sanjit Kundu all are of Matigara PS, SPC were at Jhauguri, PO- New Chumta, PS- Matigara, Dist- Darjeeling, at about 17.00 hrs on 14.02.2026, found that one Mahindra Tractor with trolley having displayed No- WB 92 H 8889 was coming from Fulbari Patan towards New Chumta Maifair road. Accordingly, I stopped the vehicle at Jhauguri and found the vehicle was loaded by the river bed materials (Sand) in the trolley of the tractor. On demand the driver could not produce any valid or relevant documents in support of said vehicles and he also failed to produce the valid documents relating to the loaded sands. On further grilling he also stated that he procured the sand fraudulently somewhere from Fulbari Patan and taking the same for disposal somewhere for his wrongful gain. Accordingly, I informed to the matter I/C, Matgara PS over telephone and as per his direction, I seized the above noted loaded vehicle by preparing proper seizure list in presence of independent witnesses, the whole process of search and seizure was made in between 17:15 hrs to 17:25 hrs by WB E- Sakshya application as per law, after that I arrested the accused driver namely Siusan Oraon (22 Years Approx), S/o- Banna Oraon of Putinbari, PO-New Chumta, PS- Matigara, Dist- Darjeeling by preparing proper memo of arrest and informed him ground of arrest.

Therefore I pray before you a specific case may kindly be started against the driver/ owner of the vehicle namely Siusan Oraon (22 Years Approx), S/o- Banna Oraon of Putinbari, PO-New Chumta, PS- Matigara, Dist- Darjeeling, and the seized vehicle bearing Reg. No. WB 92 H 8889 under proper section of law and arrange for its investigation.
