Sir,

With due respect and humble submission I SI Prokash Saha of Matigara P.S do hereby lodge this written complaint to the effect that today on 15/02/2026 I was deputed to perform morning mobile van duty along with force, vide Matigara P.S. C.C. No. 426/2026, Dated 15/02/2026 in course of said mobile duty I have received a source information that one Tractor fitted with trolley having bearing no- WB 73 E 8554 is coming from Khaprailmore side , which loaded with River bed Materials and heading towards Matigara Bazar which was procured riverbed materials clandestinely. On receipt of such information, I informed the matter to I/C Matigara PS over phone and as per his kind direction myself along with force rushed to Matigara Bazar side, PS-Matigara ,Dist-Darjeeling , and we found one Tractor fitted with trolley having bearing no- WB 73 E 8554 loaded with river bed materials was speedily running toward Matigara Bazar. After that we managed to stop the vehicle and on demand the driver/owner of the vehicle could not produced any valid document in respect of the said loaded materials. It is crystal clear that the driver/owner of the Tractor fitted with trolley having bearing no- WB 73 E 8554 is procured the river bed materials from somewhere clandestinely and was preceding to sale the same to their designated customer for their wrongful gain. Accordingly I seized the Tractor fitted with trolley having bearing no- WB 73 E 8554 with proper seizure list followed u/s 105 of BNSS also arrested the driver of the seized vehicle namely Raju Chhetri (M/42) S/O- Kalu Bahadur Chhetri, of Biscuit Factory , Panchkelguri,PS- Matigara,Dist-Darjeeling and brought the seized vehicles to Matigara P.S and kept at P.S Compound and the arrested accused kept into the P.S Lock up after mainlining proper Hazat rules. The Seizure was made in between 10:20 hrs to 10:30 Hrs.

I therefore pray before you that a specific case under proper section of Law may kindly be registered against the accused driver of the seized vehicle namely Raju Chhetri (M/42) S/O- Kalu Bahadur Chhetri, of Biscuit Factory , Panchkelguri,PS- Matigara,Dist-Darjeeling and arrange for its investigation.
