Sir

With due respect and humble submission I S.I Ramanath Karjee of Matigara P.S. Siliguri Police Commissionerate, do hereby lodge this written complaint to the effect that on 15.02.2026 I was deputed to perform K 32 Mobile Van duty along with force from 22.00 hrs dated 15.02.2026 to 08.00 hrs dated 16.02.2026. Vide C.C. No. 434 dated 15.02.2026 and GDE No. 885 Dated 15.02.2026. During the said mobile van duty I received source information that one Tractor is coming from Tarabari towards Phansidewa Underpass, Matigara side under Matigara PS loaded with river bed material which were procured clandestinely. Accordingly I informed the matter to I/C Matigara P.S over R/T Set, he immediately directed me to work out the information in hand. Accordingly, I along with force rushed to " Phansidewa underpass Matigara side and seeing police van the tractor driver tried to fly away and subsequently intercepted one Tractor with trolley vide bearing No. WB74 BQ-8202 (as shown on the number plate) loaded with river bed materials near Khaprail more under Matigara PS Dist Darjeeling. On demand, the driver of the said vehicle unable to produce any valid documents of said riverbed materials. It may be presumed that the driver/owner of said Tractor procured the loaded riverbed materials illegally and dishonestly, stealing by unfair means from somewhere, for his wrongful gain and to deliver the same to their designated customer. Finding no other alternatives, I seized the said Tractor with trolley vide bearing No. WB74 BQ- 8202 loaded with river bed materials, under proper Seizure List and arrested said driver named Surajit Barman (M/35) S/O- Bijay Barman of Dumriguri Chhat, PO- New Rangia, PS-Matigara, Dist-Darjeeling with proper Memo of arrest, Ground of Arrest. I also supply the copy of arrest memo, Seizure list and ground of arrest to the said alleged person and informed to his father over telephone and brought the alleged person with vehicle to Matigara PS. The whole process of search and seizure were made in between 07:52 hrs to 08:05 hrs on 16.02.2026 under proper videography in E- Shakshya and in presence of available witnesses.

Therefore, I pray before your kind honour that a specific case may kindly be registered against the driver/owner of vehicle no. WB74 BQ- 8202 loaded with river bed materials, and arrange for its investigation.
