I Nilima Singh wife of Rohit Kumar Singh, permanent resident of ADG Marg, near Hiranandani garden, Mumbai 400076 presently residing at Gurung Busty, P.O & P.S Pradhan Nagar would like to lodge this complaint to the effect that I have purchased a land measuring 5 decimal which is recorded in Khatian No 413, Plot No. 409(Part), J.L.No 110, Mouza- Siliguri, District Darjeeling and I have purchased the said land in the year 1996 and since then I have been using, enjoying occupying and possessing the said land in my khas actual and physical possession having every right title and interest therein. As I live outside I have kept my land vacant and seeing the vacant land, on 14/02/2026 I got news that the local land grabbers viz; Mr Ranjit Kamti and Mrs. Bina Kamti, with an ill motive is trying to grab and enter our land. When I went to my land and started reconstructing my boundary wall at that time they with other local miscreants threatened me of physical harm. I have all the original documents but inspite of having all documents he didn't bother to see my documents and vehemently refused and threw most filthy and abusive language towards me. They even threatened me that if I again try to reconstruct boundary wall they will spare no one.


