Subject: Written Complaint against a Boy for enticing and kidnapping a minor Girl

Respected Madam/Sir,

With due respect, I, Mrs. Gita Roy, W/O- Pradip Roy resident Bandrijote Dagapur Champasari of the minor girl, would like to bring to your kind notice that today, on 16th February 2026 at around 11:00 AM, our minor girl child, Miss Sonali Ray (D/O Pradip Ray), aged 16 years, resident of Dagapur Baraghariya, Champasari, was recovered from Siliguri Bus Terminus with the assistance of Tiny Hands India NGO.

The child had been missing since 15th February 2026 from around 2:00 PM. We made all possible efforts to locate her, including contacting her school friends and relatives, but we were unable to find her. Today, at approximately 10:30 AM, we received information from Tiny Hands NGO, Siliguri, that she had been found at the bus terminus accompanied by a boy named Mr. Sahanur Hussian, S/O Md. Sahidul, resident of Debottar Bokiganj, Dakshin Bara, Haldibari Dist Cooch Behar. We strongly suspect that she had run away with the same boy. This is the second time she has left home with him. Therefore, I wish to lodge a written complaint against the said boy, who kidnapped my minor daughter inducing, enticing and influencing her to leave home with him to fulfill his ill motives. We believe the child was manipulated and placed under his influence. I therefore request you to kindly accept this written complaint, take necessary legal action against the boy, and conduct a proper investigation into the matter.
